PROJECT NAME

Bothell Branch Campus Access Project

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Kemper Construction Corporation to provide construction services for the Bothell Branch Campus Access project in the amount of \$775,151 with a 10% contingency of \$77,515, for a total authorized contract amount not to exceed \$852,666.

KEY FEATURES of PROPOSED ACTION

- The proposed contract with Kemper Construction Corporation defines a scope of work for the construction of the Bothell Branch Campus Access project; it includes signalization of the north campus loop, rechannelization of North Campus Road, rechannelization of Campus Way NE, and modification of the north loop curb and sidewalk.
- These improvements will provide for more efficient transit movements in and out of the campus and will expand the operational capacity for regional and local transit service.
- On June 12, 2007 Sound Transit advertised the project for construction bids. Bids were opened July 3, 2007. The lone bidder was Kemper Construction Corporation with a bid of \$775,151, including tax. Kemper's bid exceeded the \$516,426 engineer's estimate. Kemper is qualified to provide construction services and staff believes re-advertising for construction bids would not likely result in a lower bid due to the current bid climate.

BUDGET IMPACT SUMMARY

Current Project Phase: Pre-construction

Projected Completion Date: 2007

There is no action outside of the Board-adopted budget; there are no project contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The Adopted 2007 Budget for this project is \$3,859,856, with a Board-adopted construction phase budget of \$2,062,187. The proposed action would leave a remaining construction budget of \$1,045,474 and a remaining balance for the project budget of \$2,125,044.

There are sufficient funds to complete this action within the project's preliminary engineering phase budget. Committing these funds will not endanger any other project elements that are to be funded out of the overall project.
