### PROJECT NAME

Agency-Wide Landscaping Services

## **PROPOSED ACTION**

Authorizes the chief executive officer to execute a contract with Northwest Landscape Services to provide agency-wide landscape maintenance services for a total authorized contract amount not to exceed \$627,420.

### **KEY FEATURES of PROPOSED ACTION**

- In May 2007, a Request for Proposal was solicited to provide agency-wide routine and on-call landscaping services, resulting in the selection of Northwest Landscape Services (NLS).
- The contract with NLS consolidates landscape and maintenance services throughout the Sound Transit service area into one contract.
- In June 2007, a Limited Notice to Proceed was issued to NLS in the amount of \$25,000 to provide temporary landscape and maintenance services.
- The full-term contract with NLS provides a one-year term with options to extend the contract up to four additional years.

## **BUDGET IMPACT SUMMARY**

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

## **BUDGET and FINANCIAL PLAN DISCUSSION**

The proposed action would provide general landscape services for various Sound Transit facilities. These services are budgeted for within the maintenance of stations cost section of the transit operations budgets for each mode. The 2007 budget included \$2.8 million in funding for the maintenance of stations component of transit operations; of this amount, \$181,000 was budgeted for landscape services. Through June 2007, \$26,418 had been committed to these services. The remaining balance of the 2007 budget will be used to fund part of the \$627,420 contract with the NLS. The remaining balance of the contract will be funded through the future transit operations budgets.

### PROJECT DESCRIPTION and BACKGROUND for PROPOSED ACTION

Since 2004, the Facilities Maintenance and Signage Division has managed more than seven contracts and four vendors for agency-wide landscape maintenance services. In 2007, a Request for Proposal (RFP) procurement process was initiated to procure an agency-wide landscape maintenance contract to be provided by one vendor. The RFP included the facilities covered by existing contracts plus two additional new facilities. The landscaping services will include mowing, edging, trimming, thatching, aeration, leaf and branch landscape debris and trash removal; bark mulch replacement; drainage swale, rockery, irrigation and detention pond maintenance while integrating environmentally sensitive standards recommended by the Sound Transit Sustainability Initiative. These various services will be provided on a routine and an on-call basis as required. The contract also provides for the addition of future new facilities and the ability to extend the one-year contract for four additional one-year terms.
