PROJECT NAME

Mercer Island Park-and-Ride/North Mercer Way

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Harris and Associates to provide construction management services for the Mercer Island Park-and-Ride/North Mercer Way project in the amount of \$140,452, with a contingency of \$34,000 totaling \$174,452, for a new total authorized contract amount not to exceed \$1,162,615.

KEY FEATURES of PROPOSED ACTION

- This action is needed to continue construction management services through the extended duration and closeout of the construction contract for the Mercer Island Park-and-Ride project.
- The contract time for construction of the Mercer Island Park-and-Ride has been extended a
 total of 214 calendar days to date due to the changes in the construction contract required
 by errors in the design of the garage.
- The facility is currently anticipated to be substantially complete in late October 2007. Closeout should be complete in early 2008.
- The increased funding is for costs to administer the construction contract and to provide field services and special inspections over the period of extended contract time.

BUDGET IMPACT SUMMARY

Current Project Phase: Construction

Projected Completion Date: 2007

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The amended Adopted 2007 Budget for this project is \$16,829,371. The proposed action is to increase the existing contract with Harris and Associates by \$174,452. The budget for the construction phase is \$12,730,035; this action will result in a new phase level balance of \$677,280. The project balance will be \$1,383,772.

There are sufficient funds to complete this action. Committing these funds will not endanger any other project elements that are to be funded out of the overall project.
