Resolution No. R2008-06 – Amending the Adopted 2008 Budget to: (a) Revise the Everett-Seattle Track and Signal Project lifetime budget from \$303,325,836 to \$300,369,036; (b) Revise the Snohomish County Program Reserve Project lifetime budget from \$2,237,910 to \$12,448; and (c) Revise the Everett Station lifetime budget from \$28,774,391 to \$33,956,653.

It was moved by Boardmember Butler, seconded by Boardmember Marchione, and carried by the unanimous vote of twelve Board members present that Resolution No. R2008-06 be approved as presented.

Motion No. M2008-32 – Authorizing the chief executive officer to execute a contract with Wilder <u>Construction Company to construct the Everett Station Phase 2 Project in the amount of</u> \$12,320,000 plus a 10% contingency of \$1,232,000 for a total authorized contract amount not to exceed \$13,552,000.

It was moved by Boardmember Butler, seconded by Boardmember Anderson, and carried by the unanimous vote of all Board members present that Motion No. M2008-32 be approved as presented.

Jim Moore, Transportation Services Project Manager gave the staff presentation.

### ST 2020 Draft Plan Discussion

Ms. Joni Earl gave a report requested by Chair Nickels on the draft plan discussion that took place at the April 3, 2008 Executive Committee meeting. Ms. Earl announced that more work will take place on the draft plan at the April 24, 2008 Board meeting.

Staff responded to questions from Boardmember Ladenburg about how the annual household tax for the ST 2020 Draft Plan is computed and whether expenditures in the Sound Transit district by visitors were being included in the computations.

Ms. Earl responded to questions from Boardmember Sims about the timeline for deciding when to send a plan to voters.

Boardmembers discussed the content and timing for the ST 2020 Draft Plan. Boardmembers Patterson and Conlin discussed advancing two plans at different taxing levels. Ms. Earl confirmed that plans at a .4% and .5% taxing level can be advanced by staff through the planning stages. Boardmember Conlin also asked to have an extension of the Link Connector to Aloha Street, ways to improve transit access in Shoreline, and better connections to Snohomish County included in the draft plan.
