PROJECT NAME

East Link (Phase II Planning Project – East Corridor)

PROPOSED ACTION

Authorizes the chief executive officer to execute a task order with the Washington State Department of Transportation under the Link design services umbrella agreement to provide engineering, environmental, and right-of-way services for the Phase II East Corridor High Capacity Transit planning project in the amount of \$238,813, with a 10% contingency of \$23,881, for a total authorized amount not to exceed \$262,694.

KEY FEATURES of PROPOSED ACTION

- The proposed action defines a scope of work for Washington State Department of Transportation (WSDOT) engineering support, right-of-way activities, and environmental management related to East Link conceptual engineering and draft Environmental Impact Statement (EIS) preparation. The schedule extends thru December 2008.
- The East Link light rail alternatives utilize the I-90 center roadway as well as portions of I-405 and SR 520 state right-of-way. WSDOT is participating as a SEPA co-lead on the East Link EIS.
- Planning for the conversion of the I-90 center roadway to light rail transit requires the support of WSDOT traffic, design, environmental, operations and maintenance staff. Under this task order WSDOT staff will participate in preparation of the FHWA required traffic analysis, support further design, and begin work defining the approaches necessary for future right-of-way and maintenance agreements. Additionally, WSDOT will facilitate timely review and approval of the East Link draft EIS.

BUDGET IMPACT SUMMARY

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The Adopted 2008 Budget for this project is \$17,500,000. The budget includes \$1,000,000 for 3rd Party Expenses which currently has no commitments against it. The proposed action will result in a 3rd Party Expenses balance of \$737,306, and a project balance of \$5,926,274.

There are sufficient funds to complete this action. Committing these funds will not endanger any other project elements that are to be funded out of the overall project.

PROJECT DESCRIPTION and BACKGROUND for PROPOSED ACTION

East Link is a project to provide light rail transit between Seattle, Bellevue, and Redmond via I-90 and Mercer Island. On December 14, 2006 the Board identified the light rail routes, stations, and maintenance facility alternatives to study in detail in the draft EIS.

On October 12, 2006 the Board authorized the Chief Executive Officer to (1) amend the umbrella agreement with the Washington State Department of Transportation for design review services of Link projects to include all geographical areas within the Sound Transit district and include current federal clauses; and (2) remove monetary limits established in Motion No. M2002-50. The structure established between Sound Transit and WSDOT through the umbrella agreement for design has worked well for both agencies. This task order will extend the working relationship to the East Link project.

Evaluation of the alternative project routes, stations, and maintenance facility locations identified by the Board will be conducted in cooperation with the Federal Transit Administration (FTA) and the Washington State Department of Transportation. Before committing federal funds to the East Link project, the FTA is required to undertake environmental review in compliance with the National Environmental Policy Act (NEPA). As the public agency proposing the East Link project, Sound Transit is required to comply with the State Environmental Policy Act (SEPA). The FTA, as the federal lead agency under NEPA, and Sound Transit, as the state lead agency under SEPA, have determined that alternative routes and stations in the project may have probable significant adverse environmental impacts. The Washington State Department of Transportation (WSDOT) is a SEPA co-lead agency. To satisfy both NEPA and SEPA requirements, the agencies are preparing a combined NEPA/SEPA EIS for the project.

A motion of the Finance Committee of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute a task order with the Washington State Department of Transportation under the Link design services umbrella agreement to provide engineering, environmental, and right-of-way services for the Phase II East Corridor High Capacity Transit planning project in the amount of \$238,813, with a 10% contingency of \$23,881, for a total authorized amount not to exceed \$262,694.

Background:
