PROJECT NAME

Get Ready to Ride Guide

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Northwest Publishing Center to provide printing services for the publication of Sound Transit's Get Ready to Ride Guide in the amount of \$119,000 for a new total authorized contract amount not to exceed \$314,000.

KEY FEATURES of PROPOSED ACTION

- The proposed contract amendment is needed because of two needed changes to
 printing services: (1) a change in size and binding of the "Get Ready to Ride Guide"
 (GRTR) and (2) an increase in the number of copies. The contract amendment defines
 a scope of work, including an increase in the number of copies, an increase in the
 number of pages, and a change to the binding method.
- In response to growing demand and customer needs, Sound Transit has increased the number of bus routes and level of Sounder service. In addition, riders will need information about the upcoming introduction of smart card technology and the 2009 launch of Link light rail.
- An increase in ST ridership is also driving the need to produce more copies and meet growing demand.

BUDGET IMPACT SUMMARY

There is no action outside of the Adopted 2008 Budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The proposed action will authorize an additional \$119,000 to an existing contract with Northwest Publishing Center to print Sound Transit's Get Ready to Ride Guide. The original contract was executed in 2008 in the amount of \$195,000. Through September 2008, a total of \$105,000 has been spent on this contract. The proposed amendment will bring this contract to an authorized total amount of \$314,000. For 2008, the total for Agency Transit Operations Marketing budget is \$518,808. Of this amount, \$45,000 has been budgeted for Sounder Commuter Rail's GRTR, \$83,280 for ST Express' GRTR, and \$15,000 for Tacoma Link's GRTR. These budgets are sufficient to cover the YTD expenditure and proposed expenditures combined. Expenditures beyond 2008 will be included in 2009 Get Ready to Ride budget for Sounder, ST Express, Tacoma Link and Central Link light rail, which begins operation in July 2009. The following budget table illustrates the budget impact brought by the proposed action.

The proposed action will provide enough contracting authority to change the February and June 2009 GRTR.

Analysis of Contracting Out vs. Performing In-House

Publication of GRTR requires the use of large and sophisticated printing presses and machines for folding and binding. This specialized equipment requires significant capital investment and the use of highly trained staff. In-house agency resources cannot meet this demand.

A delay beyond November 6, 2008, would create the risk of being unable to produce GRTR in time for the February 2009 service change.
