PROJECT NAME

Mobile Communications Project

PROPOSED ACTION

Authorizes the chief executive officer to execute an agreement with Community Transit to purchase and install a new radio communications system for the Sound Transit bus fleet operated by Community Transit for a total authorized contract amount not to exceed \$1,456,585.

KEY FEATURES of PROPOSED ACTION

- The purpose of this action is to provide funding to Community Transit to assist with the purchase of a new advanced communications system for Sound Transit's fleet operated by Community Transit. The system will include a number of new features to enhance customer information, communications and data collection. Community Transit's existing communication system cannot accommodate the required integration of new advanced system components.
- The Community Transit advanced communications project will provide new features to Sound Transit coaches. Chief among those features will be Global Positioning Satellite (GPS) vehicle location, automated stop announcements, visual displays and automatic passenger counting.
- The funding agreement caps Sound Transit financial participation and establishes Sound Transit as the owner of equipment installed on Sound Transit buses.
- On-board technology will enable buses to provide real time arrival information at Sound Transit facilities as envisioned in the Research and Technology's Corridor Technology Initiative.

BUDGET IMPACT SUMMARY

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The proposed action would authorize Sound Transit's participation in an advanced mobile communications project being managed by Community Transit that is currently in the final planning and procurement phase. The total Community Transit project budget is \$11,916,694. Of this amount, Sound Transit is being asked to contribute an amount not to exceed \$1,456,585 including applicable taxes for its share of the following costs upon installation of the following:

- Purchase and installation of communication equipment on forty-six (46) Sound Transit buses. \$521,283
- Purchase and installation of necessary equipment and software to implement an integrated, centralized set of intelligent transportation systems (ITS) and subsystems to provide Global Positioning Satellite (GPS) based vehicle location; automated passenger counting; automated stop announcements and displays; next bus arrival times; and integrated data communications between the vehicles and the central dispatch for all Sound Transit buses operated by Community Transit under the terms of the service agreement. \$696,678
- Purchase and installation of communication infrastructure to include central dispatching station and microwave uplink improvements to support data communications. \$106,207
- Estimated sales taxes \$132,417

The cost to Sound Transit is for the equipment installed on Sound Transit buses and a proportion of the fixed radio site and CAD/AVL infrastructure that is based on the fleet size of Sound Transit buses operated by Community Transit. The funding for this project contribution would come from the ST Express Mobile Communications project (#745), which has a lifetime budget of \$10.8 million. Of this budget, a total of \$8,907,000 has previously been committed.

Previously, Sound Transit has entered into agreements with King County Metro and Pierce Transit for similar mobile communications projects.

A motion of the Finance Committee of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute an agreement with Community Transit to purchase and install a new radio communications system for the Sound Transit bus fleet operated by Community Transit for a total authorized contract amount not to exceed \$1,456,585.

Background:

Community Transit has prepared a Mobile Communications Project to replace its radio communications system through a contract with Motorola and with INIT. Previously, Sound Transit entered into agreements with King County Metro and Pierce Transit for similar mobile communications projects.

It is hereby moved by the Finance Committee of the Central Puget Sound Regional Transit Authority that the chief executive officer is authorized to execute an agreement with Community Transit to purchase and install a new radio communications system for the Sound Transit bus fleet operated by Community Transit for a total authorized contract amount not to exceed \$1,456,585.
