# PROJECT NAME

Sounder Commuter Rail Vehicle Maintenance Strategy

## PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Raul V. Bravo + Associates to provide consulting services for the Sounder Commuter Rail Vehicle Maintenance Strategy project in the amount of \$84,000, for a new total authorized contract amount not to exceed \$283,980.

# KEY FEATURES of PROPOSED ACTION

Sounder initiated a strategy for long-term fleet maintenance with a competitive procurement process and selection of Raul Bravo + Associates (RVBA) last spring. The first phase of RVBA's work confirmed staff's own perception with an industry analysis concluding that at full build out of Sounder service, there is an opportunity for cost savings when compared to peers.

- This action is being requested because staff has identified significant potential benefits from additional technical services in analyzing fleet maintenance opportunities; the current 10-year agreement with Amtrak covers a term through 2009 and extends automatically unless either party provides notice otherwise.
- Sound Transit executed a competitively procured technical services contract with RVBA in the spring of 2007; this action allows the analysis of site-specific alternatives with a cost model that will be used for determining both capital and operating expenditures associated with specific potential maintenance facility site locations.
- RVBA accomplished great economies in compiling a large amount of high-quality information to support Sound Transit needs during the initial tasks involved with this project; this action would be the logical follow-on in augmenting the original data for a transition to Phase II – implementation work.
- An option has been exercised to extend the contract term to December 31, 2008. An additional one-year option to extend remains.

## **BUDGET IMPACT SUMMARY**

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

#### **BUDGET and FINANCIAL PLAN DISCUSSION**

The proposed action would be funded through the Sounder Commuter Rail transit operations budget. The Adopted 2008 Budget for Sounder Commuter Rail is \$32,402,190. Within that amount \$13,491,247 has been set aside for services, including consulting services. This contract is affordable within the existing budget constraints. The proposed action is consistent with the current adopted budget, and is affordable with the agency's long-term financial plan and subarea financial capacity. The action will have no new revenue impact on Sound Transit.

#### BUDGET TABLE

The proposed contract amendment will be funded by the Sounder transit operations budget, which was detailed on page 55 of the Proposed 2008 Budget Book (Resolution No. R2007-25, 2008 Budget Amendment #2 reduced Miscellaneous Services from \$865K to \$775K). The impact of this action on the budget is illustrated below:

<sup>1</sup> The existing contract is for an authorized amount of \$199,980.

<sup>2</sup> The amount committed to date is \$107,000. The proposed contract amendment would add \$70,000 plus a 20% contingency to allow for the scope of work to be completed.

<sup>3</sup> This contract will be funded by the 2008 transit operations budget, in Sounder Miscellaneous Services. The total amount budgeted in 2008 is \$775,207. The budget is sufficient to fund this contract amendment.

<sup>4</sup> This scope of work is expected to be completed during 2008. Any scope remaining at year-end would be funded through future transit operations budgets.

Raul V. Bravo + Associates is an MBE/DBE firm and will perform 100% of the work for this contract, but may draw from industry experts for additional resources to augment the existing small business staff and ensure meeting an ambitious schedule.
