#### **PROJECT NAME**

Newcastle Transit Center Project

#### PROPOSED ACTION

Authorizes the chief executive officer to 1) amend the agreement with the City of Newcastle to extend the timeline for completion of the Newcastle Transit Center project from 3<sup>rd</sup> Quarter 2009 to 1<sup>st</sup> Quarter 2010 and 2) reimburse the City of Newcastle for actual costs of the final design and construction phases of the Newcastle Transit Center project (for a total project contribution of an amount not to exceed \$4 million).

#### **KEY FEATURES of PROPOSED ACTION**

- The proposed action maintains the overall cost sharing arrangement between the City of Newcastle and Sound Transit for the preliminary engineering/environmental documentation, final design and construction phases. Sound Transit's capped contribution to the project remains at a not to exceed amount of \$4,000,000.
- The proposed action amends the project schedule to state that construction will be completed by the end of the 2<sup>nd</sup> Quarter 2009 and project closeout will be completed by 1<sup>st</sup> Quarter 2010.
- Staff advised the Board in the staff report for Motion No. M2007-19 that it would return to the Finance Committee following completion and approval of the preliminary engineering and environmental documentation to seek authorization for reimbursement of actual costs for the final design and construction phases of the project.

#### **BUDGET and FINANCIAL PLAN DISCUSSION**

The Adopted 2008 Budget for this project is \$7,222,909. The prior approved action (Motion No. M2007-19) capped Sound Transit's contribution to the City of Newcastle for preliminary engineering/environmental documentation, design and construction in the amount of \$4,000,000. The phase level budgets estimated at that time were \$250,000 for preliminary engineering/environmental documentation, \$750,000 for final design and \$3,000,000 for construction. The Proposed 2009 Budget reflects these amounts.

Saff has further defined the cost sharing of the project. While there is no change to Sound Transit's total commitment, there is a change to the phase level commitments. The new commitments are \$226,373 for preliminary engineering/environmental documentation, \$386,732 for final design and \$3,386,895 for construction. The change in commitments is reflected in the Bdget table section of this report.

The phase reallocation of the \$4 million will result in a construction phase shortfall of \$387,000 and a surplus in preliminary engineering/environmental documentation and final design totaling \$389,000. The Proposed 2009 Budget will reflect these changes.

The City of Newcastle, Sound Transit, and King County Metro have worked for several years to determine an appropriate location and level of investment for a transit center in Newcastle. In October 2003, a site selection study concluded that a transit center should be located at SE 70<sup>th</sup> Street and 132<sup>nd</sup> Place SE, keeping with the City's long term goal of expanding its city center core. The 30% design for a transit center at this location was completed in 2005. Subsequently, the City of Newcastle determined that the proposed transit center at SE 70<sup>th</sup> Street and 132<sup>nd</sup> Place SE was not in keeping with the existing and near term development

plans in the City's existing core area, south of SE 70<sup>th</sup> Street. The decision by the City not to locate the transit center in the existing core area was prompted by discussions between the City of Newcastle and the King County Library System to co-locate a number of public and private facilities, including a re-located Sound Transit facility, on property in and around the current city hall facility. Although the negotiations between the City of Newcastle and King County Library System eventually failed, the City of Newcastle and Sound Transit agreed on the current proposal which places the transit facility at Newcastle Way and Coal Creek Parkway - the City's busiest and most visible intersection.

As a result, the City of Newcastle, Sound Transit and King County Metro identified improvements that will support transit service in the core area on two major transit corridors in the City (Newcastle Way and Coal Creek Parkway). In February 2007, the Board authorized the chief executive officer to enter into an agreement with the City of Newcastle to provide \$4,000,000 in a capped contribution toward the construction of:

- Four new bus shelters, with the accommodation of three additional bus shelters in the future;
- Intersection improvements at Coal Creek Parkway and Newcastle Way, including reconstruction of sidewalks and driveways to be ADA compliant and pedestrian islands;
- Bike lanes along the Newcastle Way corridor between 129<sup>th</sup> Avenue SE and 132<sup>nd</sup> Avenue SE:
- Relocation and modification of the signal system at Newcastle Way and Coal Creek Parkway; and
- Approximately 850 linear feet of 12-foot wide sidewalks along the north and south sides
  of Newcastle Way between 129<sup>th</sup> Avenue SE and 132<sup>nd</sup> Avenue SE.

These improvements will provide a benefit to transit by improving local access for the City of Newcastle residents to King County Metro service and, as a result, to Sound Transit's regional service. The transit center will be owned and maintained by the City of Newcastle.

Staff advised that it would return to the Finance Committee following completion and approval of the preliminary engineering and environmental documentation to seek authorization for reimbursement of actual costs for the remaining phases (final design and construction) of the project.

Sound Transit and the City of Newcastle are co-lead agencies. The City of Newcastle is the nominal lead agency under SEPA as per WAC 197-11-944. The City issued a Determination of Nonsignificance (DNS) under WAC 197-11-340(2) on June 10, 2008. The SEPA appeal period ended on July 22, 2008. No appeals were submitted.

Sound Transit staff has reviewed and commented on 30% designs and agrees that the project should proceed to Final Design.
