## PROJECT NAME

**Mobile Communications Project** 

## PROPOSED ACTION

Authorizes the chief executive officer to execute an agreement with King County to purchase and install a new radio communications system for Sound Transit's Express bus fleet operated by King County for a total authorized contract amount not to exceed \$2,700,000.

## KEY FEATURES of PROPOSED ACTION

- The purpose of this action is to provide funding to purchase a new communications system for Sound Transit's ST Express bus fleet and acquire new features for customer convenience. The existing equipment cannot accommodate the required integration of new systems.
- This action will allow the communications capability of Sound Transit's ST Express bus fleet with the centralized communications system used by King County to be maintained. Federal Communications Commission (FCC) changes are making current equipment obsolete.
- The King County Mobile Communications Project will provide new features to Sound Transit buses; including GPS vehicle location, automatic stop announcements and displays, and improved automatic passenger counting and vehicle communications.
- The contract defines a scope of work, including financing and ownership of equipment.
- On-board technologies will be compatible with real-time information at Sound Transit facilities as envisioned in Sound Transit's Research and Technology's Corridor Technology Initiative.

# **BUDGET IMPACT SUMMARY**

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

# **BUDGET and FINANCIAL PLAN DISCUSSION**

The proposed action would authorize funding for Sound Transit to participate in a mobile communications project being managed by King County that is currently in the final planning and procurement phases. The total King County project budget is \$76.6 million. Of this amount, Sound Transit is being asked to contribute an amount of \$2.42 million plus tax. Sound Transit's contribution is for the communications hardware that would be installed on its buses and a proportion of the programming based on fleet size. The funding for this project contribution would come from the ST Express Mobile Communications project (#745), which has a lifetime budget of \$10.8 million. Of this budget, a total of \$5.7 million has previously been committed.

Sound Transit has entered into a project agreement with Pierce Transit for a similar mobile communications project, authorized by Motion No. M2007-78. The remaining uncommitted budget is anticipated to be necessary for a third project that will be undertaken by Community Transit in the near future. A project agreement with Community Transit would be authorized by the Board separately.

The amount of this agreement would be used to fund the purchase and installation of equipment and infrastructure necessary to ensure continued ST Express operations. A payment schedule was developed to reflect payments tied to project milestones as described below:

A motion of the Finance Committee of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute an agreement with King County to purchase and install a new radio communications system for Sound Transit's Express bus fleet operated by King County for a total authorized contract amount not to exceed \$2,700,000.
