# **PROJECT NAME**

Sounder Commuter Rail-Edmonds Station

# **PROPOSED ACTION**

Ratifies the lease holdover period with Thrifty Park, Inc., at Edmonds Station from April 27, 2009 to June 6, 2009.

Authorizes the Chief Executive Officer to extend the lease agreement with Thrifty Park, Inc., on a month-to month basis until the Edmonds Commuter Rail Station is ready to begin construction.

# **KEY FEATURES of PROPOSED ACTION**

- The lease with Thrifty Park, Inc., was originally executed within the chief executive officer's delegated authority and has been in effect for five years. Board approval of the lease is being requested in order to comply with Board policy requiring approval of agreements with terms that exceed five years.
- This lease was scheduled to terminate upon commencement of the Edmonds Crossing Project. Due to the revision of that project, this agreement can be extended until construction begins on the Edmonds Commuter Rail Station, currently planned for June 2010.

# **BUDGET IMPACT SUMMARY**

There is no action outside of the Board adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

# **BUDGET and FINANCIAL PLAN DISCUSSION**

The proposed action will ratify Thrifty Park, Inc's month-to-month lease commencing April 27 and ending June 6, 2009. Because the revenues generated from this action were not budgeted in 2009, it has a positive impact on the Agency's revenues.

Sound Transit purchased the property at Edmonds from Burlington Northern Santa Fe Railroad on March 25, 2004 for the Sounder Commuter Rail Edmonds Station Project in accordance with Resolution No. R2000-10. Thrifty Park had an existing lease at this location. Sound Transit renegotiated a new agreement on April 26, 2004.

Sound Transit granted Thrifty Park, Inc., a lease for 51 parking stalls on a 24 hour, seven day a week basis and 191 stalls during non-commuter hours (commuter hours are "weekdays from 6:00 am to 7:00 pm"). The lease may be revoked by Sound Transit with a minimum 30 days notice to Thrifty Park, Inc. The rent is equal to 82.5% of net receipts (gross revenue less all state and local sales taxes). The average monthly revenue for the past 12 months has been \$6,009.78.

This lease assists in the enforcement of Sound Transit's parking regulations and supports customer access to Sounder Commuter Rail.
