PROJECT NAME

Sounder - D Street to M Street Track and Signal Project Development Agreement, Master Utilities Licensing Agreement, and Right of Use Agreement

PROPOSED ACTION

Authorizes the chief executive officer to execute three agreements with the City of Tacoma: the Master Utilities Licensing Agreement, the Right of Use Agreement, and the D Street to M Street Track and Signal Development Agreement, and to execute all other subsequent agreements with the City of Tacoma as may be necessary to implement these agreements, for a total authorized expenditure not to exceed \$1,212,349.

KEY FEATURES of PROPOSED ACTION

The Project Development Agreement establishes roles, responsibilities, terms, and conditions regarding the design and construction of the D Street to M Street Track and Signal project. The Master Utilities Licensing Agreement and the Right of Use Agreement are programmatic agreements covering the use of Sound Transit and City of Tacoma rights of way.

Project Development Agreement (DA):

- Specific to the D Street to M Street Track and Signal project.
- Acknowledges that the project is an essential public facility.
- Establishes the development standards for the project and creates a ten-year vesting period for those standards.
- Defines the process for obtaining approval of the project design and required permits from the City of Tacoma.
- Establishes a maximum amount of \$1,212,349 to be paid by Sound Transit to the City of Tacoma for design review and approvals, permits, and construction inspections of the project.

Master Utilities License Agreement (MULA):

- Programmatic agreement covering city use of Sound Transit right of way.
- Places most existing utility crossings and other incidental city uses of the Sound Transit railroad right-of-way under perpetual licenses with uniform conditions.
- Establishes procedure for licensing existing but unknown crossings, upon their discovery and documentation.
- Establishes a uniform and streamlined procedure licensing new utility crossings.

Right of Use Agreement (ROU):

- Programmatic agreement covering Sound Transit use of city right of way.
- Grants Sound Transit the perpetual right to construct track facilities and operate trains over and upon city rights of way.
- Establishes a procedure in the event additional use of city right-of-way is needed.
- Details maintenance responsibilities within the right of use areas.

BUDGET IMPACT SUMMARY

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The project's total budget is \$161,580,747, with a final design phase budget of \$14,364,264 and a construction phase budget of \$71,128,693. The proposed action is to execute agreements with the City of Tacoma which include a capped contribution by Sound Transit of \$1,212,349, with \$969,036 in final design and \$243,313 in construction. This action will result in a final design phase balance of \$2,733,977 and a construction phase balance of \$70,731,539. The proposed action will leave a project balance of \$103,213,034.

There are sufficient funds to complete this action within the project budget. Committing these funds will not endanger any other project elements that are to be funded out of the overall project.

PROJECT DESCRIPTION and BACKGROUND for PROPOSED ACTION

The D Street to M Street Track and Signal project will connect the Tacoma Dome Station, the southern terminus of current Sounder commuter rail service, with Sound Transit's existing rail right-of-way at Tacoma Avenue South and extend track and signal improvements westward to join the improvements of the M Street to Lakewood Track and Signal project. The Sound Transit Board selected an alignment in December 2007 that provides grade-separation over Pacific Avenue. Final design of the project began in July 2008. Resolution No. R2009-19, approved by the Board on September 24, 2009, amended the Adopted 2009 Budget and established the project budget at \$161M.

On October 20, 2009, the Tacoma City Council unanimously approved Resolution No. 37897 authorizing execution of the MULA, Ordinance No. 27833 authorizing approval of the ROU, and Substitute Resolution No. 37898 authorizing the execution of the DA.

Substitute Resolution No. 37898 includes two amendments. The first amendment addresses the appearance of the rail bridge as it passes over Pacific Avenue, requiring Sound Transit to submit aesthetic options for the bridge's treatment (color, lighting, and decoration) to the city for review prior to issuing the building permit. The second amendment requires the city and Sound Transit to jointly hire appropriate firms to 1) design the habitat improvements for the "B" Street gulch, 2) design the landscape improvements for the project, and 3) set in place an agreement to maintain the habitat and landscape improvements.

The MULA and the ROU are programmatic agreements, intended to be perpetual, detailing how each party will act in the other's right-of-way. These agreements create certainty and predictability for the city to place and maintain utilities within the railroad right-of-way as well as for Sound Transit to place track and run trains across street right-of-way. This includes a NEPA/SEPA Final EIS (2002) for the Lakewood to Tacoma Commuter Rail project, and a SEPA Addendum (2007) evaluating the impacts of alignment changes for the revised D to M Street alignment selected by the Sound Transit Board to be constructed (Alternative 3 Modified).

Between November 2006 and January 2009, Sound Transit briefed Tacoma City Council on three occasions:

- 11/22/06: Session for General Council to evaluate preliminary results of feasibility review and AIA options.
- 1/23/09: Project update session for Council's Environmental & Public Works Committee.
- 1/27/09: Project update session for General Council.

On June 8, 2009, Sound Transit held a public Open House to share the proposed alignment for the Lakewood-to-Tacoma stretch. The focus of the meeting was to provide a project update and give opportunity to submit written comment.
