# **PROPOSED ACTION**

Authorizes the chief executive officer to execute a one-year contract with four one-year options with Buenavista Services Inc. to provide system-wide janitorial services for Union Station and Sound Transit facilities not maintained through agreements with partner transit agencies, for a total authorized contract amount not to exceed \$2,241,144.

# **KEY FEATURES**

- The contract covers facilities for ST Express, Sounder, and Tacoma Link facilities. Central Link facilities are not covered under this contract because they are maintained through an agreement with King County Metro.
- The scope of work includes daily office cleaning; carpet cleaning and window washing; cleaning and trash removal at transit platforms and facilities; and cleaning of Tacoma Link light rail vehicles and asneeded cleaning of non-revenue fleet vehicles.
- The amount requested is sufficient to cover the one-year contract and all four one-year options.

# **PROJECT DESCRIPTION**

Sound Transit is responsible for janitorial maintenance at 29 facilities used by ST Express, Sounder and Tacoma Link.

There are seven existing janitorial contracts managed by the Facilities Maintenance Division that will expire or be cancelled and replaced upon approval of this single contract. The scope of work in this contract will encompass all of the facilities and scopes of work in the previous contracts.

Buenavista Services Inc. is currently providing janitorial services at East King County ST Express transit centers, Pierce County Sounder stations, ST Express transit centers, Union Station, Weller Street Bridge, and King Street Station platform pursuant to an interim contract for a not-to-exceed amount of \$48,000. The interim contract was issued to ensure that janitorial services continued uninterrupted, until the new Agency-wide contract was in place. If the Board approves this action, the interim contract will be replaced by the approved contract. If the Board does not approve this recommendation for award of contract, the interim contract will be extended to allow re-procurement of these services.

Sound Transit's historical janitorial maintenance costs were used to prepare the Independent Cost Estimate (ICE) for the Invitation For Bid process. Of the ten bids received, four were below the ICE and Buenavista Services Inc. submitted the lowest, responsive and responsible bid and is 37% below the ICE.

## Analysis of Contracting Out vs. Performing In-House

Performing janitorial service with Sound Transit employees is not a practical option due to the high initial cost to acquire and maintain equipment and establish a maintenance and storage facility.
