PROPOSED ACTION

Authorizes the chief executive officer to execute a one-year contract with four one-year options with Vinson Brothers Corporation to provide system-wide landscape maintenance services for Union Station, and Sound Transit facilities not maintained through agreements with partner transit agencies, for a total authorized contract amount not to exceed \$931,718.

KEY FEATURES

- The contract covers ST Express, Sounder and Tacoma Link facilities. Central Link facilities are not covered under this contract because they are maintained through an agreement with King County Metro.
- The scope of work includes mowing, weeding, edging, pruning, fertilization, watering and irrigation system maintenance, mulch replacement, rockery maintenance, and removal of landscape debris and trash for 25 facilities.
- Landscaping services not included in this contract are Sound Transit facilities maintained by agreements with our partner transit agencies.
- The amount requested is sufficient to cover the one-year contract and all four one-year options.

PROJECT DESCRIPTION

Sound Transit is currently responsible for landscape maintenance at 21 facilities used by ST Express, Sounder and Tacoma Link. An additional four facilities will begin service during the contract term for a total of 25 facilities covered by this contract.

Previously, the division managed three landscaping contracts. Those contracts have expired or will expire and be replaced with the approval of this contract. Sound Transit's historical landscape maintenance costs were used to prepare the Independent Cost Estimate (ICE) for the Invitation For Bid process. Of the seven bids received, three were below the ICE. Vinson Brothers Corporation submitted the lowest responsive and responsible bid and was 45% below the ICE.
