PROPOSED ACTION

Authorizes the chief executive officer to execute an operations and maintenance agreement with the Western Washington Fair Association for the Puyallup Parking Expansion project for a total authorized amount not to exceed \$160,000.

KEY FEATURES

- The Puyallup Parking Expansion Project provides an additional 219 parking spaces for Puyallup Sounder Commuter Rail Station customers.
- This agreement provides for the operations and maintenance of the Red Lot for five years.
- Sound Transit will pay the Western Washington Fair Association (Fair) \$12,000 annually for routine maintenance. Routine maintenance includes weekly trash pickup, cleaning blacktop, all landscaping, pesticide control and tree pruning.
- Included in the agreement are contributions for Sound Transit to negotiate non-routine or emergency maintenance as needed. Non-routine or emergency maintenance shall not exceed \$20,000 per year.
- The combined total for routine maintenance, non-routine and emergency maintenance shall not exceed \$32,000 per year or \$160,000 for the five-year period.
- Motion No. M2010-26, approved by the Finance Committee in February 2010, committed to bringing this
 agreement to the Committee for consideration.

PROJECT DESCRIPTION

In 2007, Sound Transit received a Regional Mobility grant in the amount of \$3.7 million to expand commuter rail parking in the Tacoma-Seattle Corridor. The local match for this grant is \$500,000. As a result of the grant and matching funds, the 2009 budget was increased to add scope. In exchange for capital improvements at the Puyallup Fairgrounds, Sound Transit will be able to enter into agreements to significantly expand the parking available for Sounder customers during commute periods.

BACKGROUND

High demand for Sounder commuter rail service along the Tacoma-Seattle corridor has resulted in spillover parking in neighborhoods adjacent to the commuter rail stations in Puyallup, Sumner, and Auburn. Combined with a \$500,000 local match, Sound Transit received a \$3.7 million Regional Mobility Grant from the Washington State Department of Transportation in 2007 to increase parking capacity for these stations for a total of \$4.2 million. Sound Transit also received a \$772,000 Federal Transit Administration grant obtained by the City of Puyallup, which was used for the design work for the Puyallup Parking Expansion project.

In February 2010, Sound Transit entered into a development agreement with the Fair and the City of Puyallup to improve the Fair-owned Red Lot. The Red Lot, located at 5th Street SW and 7th Avenue SW in Puyallup, was an unimproved surface lot owned and primarily used by the Fair for event parking. This project, which is substantially complete, will create an initial 219 parking spaces for Sound Transit commuters, with the potential for additional capacity up to a maximum total of 625 spaces, subject to negotiation with the Fair. The development agreement included improvements to the Red Lot such as paving, stripping, landscaping and irrigation, and lighting. Under the agreement, Sound Transit received a 25-year easement for use of the Red Lot.

This proposed action provides for the operations and maintenance of the Red Lot for five years. Future years would need to be negotiated.

On October 1, 2010, the Red Lot will be available to commuters. The Red Lot will be served by Pierce Transit route # 495, which is an existing route that will shuttle commuters from the lot to Puyallup Station. Commuters will be allowed to use the lot Monday through Friday from 4:30am to 6:30pm, except during the fair season in September of each year.

ENVIRONMENTAL COMPLIANCE

Sound Transit has completed NEPA and SEPA environmental documentation for this project. FTA approved a NEPA Documented Categorical Exclusion (DCE) on September 22, 2009. As co-lead agencies under SEPA, Sound Transit and the City of Puyallup completed a SEPA checklist and issued a SEPA Determination of Nonsignificance (DNS) on September 4, 2009.

PRIOR BOARD/COMMITTEE ACTIONS

Motion No. M2010-41 — Authorized the chief executive officer to execute a contract with Construct Company to provide construction services for the Puyallup Parking Expansion project in the amount of \$1,701,178, with a 10% contingency of \$170,118, for a total authorized contract amount not to exceed \$1,871,296

Motion No. M2010-27 — Authorized the chief executive officer to execute a three-party development agreement with the City of Puyallup and the Western Washington Fair Association for the Puyallup Parking Expansion Project

The Operations and Maintenance Agreement should be in place before October 1, 2010 when Sound Transit begins using the lot.

A motion of the Operations and Administration Committee of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute an operations and maintenance agreement with the Western Washington Fair Association for the Puyallup Parking Expansion project for a total authorized amount not to exceed \$160,000.

Included in the agreement are contributions for Sound Transit to negotiate non-routine or emergency maintenance as needed. Non-routine or emergency maintenance shall not exceed \$20,000 per year. The combined total for routine maintenance, non-routine and emergency maintenance shall not exceed \$32,000 per year or \$160,000 for the five-year period.

Motion No. M2010-26, approved by the Finance Committee in February 2010, committed to bringing this agreement to the Committee for consideration.

On October 1, 2010, the Red Lot will be available to commuters. The Red Lot will be served by Pierce Transit route # 495, which is an existing route that will shuttle commuters from the lot to Puyallup Station. Commuters will be allowed to use the lot Monday through Friday from 4:30am to 6:30pm, except during the fair season in September of each year.
