Agreement with King County for Receipt of Federal Funds in Exchange for Increased Transit Service on SR 520

PROPOSED ACTION

Authorizes the chief executive officer to execute an agreement with King County for the receipt of \$8,515,000 in federal grant funds to partially cover the cost of eleven new hybrid diesel-electric buses to support increased transit service in the SR 520 corridor.

KEY FEATURES

- In 2009, King County, the Washington State Department of Transportation and the Puget Sound Regional Council entered into a \$139 million Urban Partnership Agreement (UPA) with the Federal Government to enhance mobility in the SR 520 corridor.
- This agreement allows King County to meet its obligations under the UPA through Sound Transit's contribution of forty-eight additional one-way peak period trips in the SR 520 corridor on Route 542. Under this agreement, Sound Transit is obligated to provide the forty-eight one-way peak period trips and to continue 121 current one-way peak period trips in the corridor through June 30, 2012.
- Under this agreement, King County agrees to reimburse Sound Transit \$8,515,000 in federal grant funds for the cost of eleven new hybrid diesel-electric buses needed for providing the additional service in the corridor.
- The additional service on the SR 520 corridor is a part of the agency's ST2 Plan and is included in the Board adopted 2010 Service Implementation Plan (SIP).

PROJECT DESCRIPTION

King County, PSRC and WSDOT entered into an agreement in September 2009 titled "The Lake Washington Urban Partnership Agreement," to apply for funding from the Federal Transit Administration and Federal Highway Administration. The Urban Partnership Agreement was tied to the urgent need for replacement of the SR 520 Lake Washington floating bridge.

The partnership proposed improving traffic flow by rigorously pursuing congestion reduction strategies across Lake Washington including the 4Ts: tolling (congestion pricing), transit, telecommuting/transportation demand management, and technology. A key element of the UPA is to provide enhanced transit service in the SR 520/Trans-Lake Washington corridor to supplement the other traffic flow improvement elements and reduce congestion. Under the UPA, transit service is to expand along SR 520 by adding 90 one-way peak period trips on core and other supporting bus routes. Sound Transit will provide 48 of those trips and King County will provide the remainder of those trips.

The Urban Partnership proposal was successful and the project was awarded \$139 million in federal funds. \$41 million of the award was specifically allocated for transit capital improvements in the corridor.

FISCAL INFORMATION

The grant funds will be applied to the procurement of buses which have already been purchased and delivered.

The buses were procured prior to executing this agreement because Sound Transit was already planning to acquire these eleven buses for expanded service in the SR 520 corridor as identified in the 2010 SIP and ST2 Plan. Sound Transit agreed to dedicate these buses for expanded service in the corridor as required under the UPA.
