PROPOSED ACTION

Authorizes the chief executive officer to execute an amendment to the lease with Puget Sound Clean Air Agency for the ambient air monitoring station located at the Kent Sounder Station until Sound Transit requires use of the land in the amount of \$1,750 per year with annual increases based on the consumer price index.

KEY FEATURES SUMMARY

- Sound Transit leases 546 sq. ft. to Puget Sound Clean Air Agency (PSCAA) for their ambient air monitoring station located at Kent Station and PSCAA is requesting an extension to the lease.
- The initial lease term was for five years, beginning in July 2008 and will expire on June 1, 2013.
- Sound Transit has, and will retain, the right to terminate the lease agreement upon 90-days written notice.
- Resolution No. 78-2 requires all lease agreements with a term greater than five years be approved by the Board.
- PSCAA is paying current market rate and will receive an annual rent increase.

BACKGROUND

Before Sound Transit purchased properties in the area of the Kent Sounder Station, WSDOT and PSCAA had a signed lease agreement allowing PSCAA to lease property for its ambient air monitoring station. The ambient air monitoring station measures air quality and fine particle for the Environmental Protection Agency. The station is visited every two weeks by a PSCAA maintenance technician.

In April 2002, Sound Transit purchased land from the Washington Department of Transportation (WSDOT) to construct the Kent Sounder Station. After purchasing the land, Sound Transit and PSCAA executed a lease to allow PSCAA's ambient air monitoring station to remain on site. Sound Transit has collected \$7,500 to date under this lease.

FISCAL IMPACT

Lease revenues are included within the miscellaneous revenues the agency receives. The PSCAA annual lease revenue of \$1,750 is included within the adopted 2013 miscellaneous revenue budget of \$11.1 million.
