Task order with Pierce Transit to replace existing mobile two-way radios on Sound Transit buses operated by Pierce Transit

PROPOSED ACTION

Authorizes the chief executive officer to execute a task order under an existing agreement with Pierce Transit to purchase and install replacement two-way radios, including spares, on Sound Transit owned buses operated by Pierce Transit in the amount of \$553,240, with a 5% contingency of \$27,662, for a total authorized task order amount not to exceed \$580,902.

KEY FEATURES SUMMARY

- Pierce Transit needs to upgrade and replace their existing radio system in order to be compliant
 with new Federal Communications Commission (FCC) radio frequency changes effective January
 1, 2017. The radio system provides basic two-way voice communication between buses,
 dispatchers and street supervisors.
- Pierce Transit's project is part of a larger Pierce County radio upgrade involving public agencies in the county, including emergency service providers.
- The radio equipment has been advertised and competitively procured as part of the Western States Contracting Alliance (WSCA) contract.
- The project includes 133 Motorola APX Voice Mobile Radios (including 20 spares) at a unit cost of \$3,706, plus 9.4% sales tax. Total cost for installation labor is estimated at \$13,961. This task order is timed to take advantage of pricing discounts provided by WSCA for early purchase.
- As part of Pierce County's new system, the new radios will provide coverage well into King County and will allow for interoperability with other Pierce County agencies.
- Pierce Transit will cover costs associated with infrastructure improvements to their transit base.
 Sound Transit is paying for its proportionate share of the radios used in operation, including mobiles, spares, and handheld radios.
- Contingency amount of \$27,662 is to cover any unforeseen costs associated with installation of the new radios.

BACKGROUND

In 2008 Pierce Transit had to replace their existing 900MHz system with a newer 800MHz system because their 900MHz system was outdated and failing. In 2013 the FCC published new frequency requirements that go into effect on January 1, 2017. This new requirement makes it necessary for 800MHz systems to digitally divide down within the frequency spectrum to make room for more frequencies within that bandwidth. Pierce Transit's 800MHz radios do not currently have the necessary digital capability to perform this function and will be obsolete, so they need to upgrade and replace their existing radio system in order to be compliant with new FCC requirements.

As part of WSCA, the State of Washington went out as the lead for a blanket radio bid, and Motorola was the lowest bidder. The pricing in this action reflects a 20% discount for early purchase and a 10% discount from Motorola for a high-volume purchase. The discounts were applied to the bid price from the state contract.

This action to purchase radios for Sound Transit buses is part of a larger Pierce County radio upgrade involving public agencies in the county, including emergency service providers. The radio system funded through this action provides basic two-way voice communication between buses, dispatchers and street supervisors. If this action is approved, Sound Transit expects to receive the new radios in the third quarter of 2014, and the radios are expected to be installed in Sound Transit owned buses operated by Pierce Transit in third quarter 2014.

FISCAL INFORMATION

This action authorizes the purchase of 133 radios in order to meet FCC mandated radio frequency changes taking effect January 1, 2017. The early purchase of these radios in advance of the effective date ensures equipment compliance and availability to meet the requirement and allow taking advantage of manufacturer discounts extended to early purchasers.

The early purchase and volume discounts extended to this transaction result in a total savings of \$211,261 from the WSCA list price, before contingency.

This action is part of a radio upgrade competitively procured via the Western States Contracting Alliance (WSCA) contract by Pierce County to assure compliance with Federal Communications Commission (FCC) radio frequency changes effective January 1, 2017 and for which Sound Transit is paying its proportionate share. Any determination and administration of Small Busines/DBE participation would be the sole responsibility of Pierce Transit.

TIME CONSTRAINTS

A one month delay would not create a significant impact to the project schedule.

PRIOR BOARD/COMMITTEE ACTIONS
