Contract for Construction Services for the ST Express Mid-day Bus Storage Project

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Gary Merlino Construction Company Inc. to provide construction services for the ST Express Mid-day Bus Storage Project in the amount of \$1,093,500, with a 10% contingency of \$109,350, for a total authorized contract amount not to exceed \$1,202,850.

KEY FEATURES SUMMARY

- The project will construct a permanent parking area to be used by up to 30 Sound Transit buses during the mid-day layover period.
- The scope of work includes grading, paving, striping, drainage, landscaping, and construction of fence and a retaining wall.
- Eight bids were received on October 31, 2014; the low bid submitted by Gary Merlino Construction Company Inc. is under the engineer's estimate of \$1,443,996. This action is contingent upon expiration of the bid protest period, estimated to be November 21, 2014 and resolution of any protests that may be received, if any.
- Construction is expected to begin in December 2014 and last approximately four months.

BACKGROUND

The ST Express Bus Base project is a component of the voter-approved ST2 plan and is included in the 2014 Transit Improvement Plan (TIP). The Proposed 2012 Budget was amended by the Board on December 15, 2011 to add the ST Express Mid-day Bus Storage project as a component of the Bus Base project. The Mid-day Bus Storage project has passed through Gates 1 through 6 of the Agency's Phase Gate process for capital project management.

Sound Transit currently stores 30 buses that are operated by Pierce Transit, these buses provide peak hour service between Seattle and Tacoma. The buses are stored at the Link Operations Maintenance Facility (OMF) employee parking area during the day. Storing these buses at the OMF saves approximately \$300,000 to \$500,000 per year in fuel costs, plus mileage and vehicle maintenance costs, as the buses do not need to travel between Seattle and Pierce County during the mid-day. A permanent mid-day storage site is needed because the parking area that currently holds the Sound Transit buses will be utilized in 2015 for drivers hired to test light rail vehicles for the University Link and South 200th Link Extensions.

The site that has been identified for the project is land acquired by Sound Transit for the Beacon Hill Tunnel. There is no cost for the property since it is already owned by Sound Transit. The project location will allow buses to quickly begin their return trips in downtown Seattle to the Tacoma area.

Elements of the project include: grading, paving, striping, drainage, landscaping, and construction of fence and a retaining wall to protect the backup generator for the Link light rail tunnel ventilation

system. The site will only be used during the day on weekdays, and will be secured when not in use. Access to the backup generator at the site will be maintained and protected.

Environmental review for this project was completed with Sound Transit issuing a SEPA Checklist and a Determination of Non-significance (DNS) on November 15, 2012.

FISCAL INFORMATION

The Lifetime project budget for the ST Express Mid-Day Bus Storage, as amended in 2014, is \$3,128,000. Within that amount, \$1,961,000 has been set aside in the Construction phase. This proposed action will commit \$1,202,850, including a 10% contract contingency to this phase, leaving a remaining balance of \$752,504.

This action is within the adopted budget and sufficient monies remain after approval of this action to fund the remaining work in the construction phase as contained in the current cost estimates.

A motion of the Capital Committee of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute a contract with Gary Merlino Construction Company Inc. to provide construction services for the ST Express Mid-day Bus Storage Project in the amount of \$1,093,500, with a 10% contingency of \$109,350, for a total authorized contract amount not to exceed \$1,202,850.
