#### PROPOSED ACTION

Authorizes the chief executive officer to execute an agreement with the joint venture of Stacy and Witbeck/Atkinson Construction to provide pre-construction services for the Downtown Bellevue to Spring District contract within the East Link Extension in the amount of \$2,510,215, with a contingency of \$251,022, for a total authorized contract amount not to exceed \$2,761,237.

### **KEY FEATURES SUMMARY**

- The proposed contract uses the Heavy Civil General Contractor/Construction Manager (GC/CM) contracting method. This contracting method was selected based on certain project characteristics including complex scheduling and phasing requirements and extensive interface with other contractors.
- The pre-construction services for the Downtown Bellevue to Spring District work will include:
  - Participating in development of final construction plans;
  - o Preparing construction schedules and subcontracting plans;
  - Developing cost estimates for construction;
  - Risk management;
  - Value engineering;
  - o Constructability reviews.
- Pre-construction services will last approximately 15 months and will be concurrent with the final design of the Downtown Bellevue to Spring District contract package.
- Following pre-construction phase activities, Sound Transit will negotiate a Maximum
  Allowable Construction Cost (MACC) with Stacy and Witbeck/Atkinson Construction which
  will be the basis for award of the GC/CM construction contract. If MACC negotiations are
  successful, the construction contract to build the facilities will be brought to the Board for
  consideration.

### **BACKGROUND**

East Link extends light rail 14 miles from downtown Seattle to downtown Bellevue and the Overlake area of Redmond via I-90, with stations serving Rainier Avenue/I-90, Mercer Island, South Bellevue, Downtown Bellevue, Overlake Hospital, the Bel-Red Corridor, Overlake Village, and the Overlake Transit Center. The East Link project route, profiles, and station locations, including the tunnel route in downtown Bellevue, were selected by the Sound Transit Board on July 28, 2011, and amended on April 25, 2013. Light rail service between Seattle and the Overlake Transit Center is forecasted to begin in 2023.

As part of early work in the Final Design phase, a construction delivery plan was developed which includes the contract packaging and delivery strategy as well as the construction management packaging plan. The Downtown Bellevue to Spring District construction contract includes four stations East Main, Bellevue Transit Center, Hospital, and 120th The project includes elevated, at-grade and retained cut/fill guideway, storage tracks along the former BNSF corridor and civil/system infrastructure.

A Request for Qualifications for the GC/CM contract for the Downtown Bellevue to Spring District section was issued on June 20, 2014 and six Statements of Qualifications (SOQs) were received. Following review and evaluation, three firms were invited for interviews. Based on scoring of the SOQs and the interviews, all three firms were invited to submit final proposals including price offers for specified work items. The price offers were opened publicly on October 16, 2014. Based on evaluation of the SOQs, interviews, and price offers, Stacy and Witbeck/Atkinson Construction was the highest ranked firm.

Consistent with the GC/CM process, following completion of pre-construction services, Sound Transit will negotiate a MACC with the contractor. If a MACC is agreed to, a construction contract with Stacy and Witbeck/Atkinson Construction will come back to the Board for consideration, targeted for the spring of 2016. If an agreement on the MACC cannot be reached, Sound Transit will have the option of bidding the work through a traditional Invitation for Bids (IFB) or entering cost negotiations with the second ranked team.

# **FISCAL INFORMATION**

The Lifetime Budget for the East Link Extension project through the final design phase is \$798,346,894. Within that amount, \$11,000,000 has been set aside for the Construction Services Phase. Of that amount \$6,778,500 has been previously committed for the Construction Services Phase. The proposed action would commit \$2,761,237 for the segment E335 (Downtown Bellevue to Spring District) General Contractor/Construction Manager (GC/CM) Pre-Construction Services contract leaving a remaining uncommitted budget of \$1,460,263 in the Construction Services Phase.

This action is within the Adopted Budget and sufficient funds remain after approval of this action to fund the remaining work in the Construction Services Phase as contained in the current cost estimates.

# Participation by Small Businesses and Disadvantaged Business Enterprises (DBEs)

Sound Transit promotes and encourages small business participation, which also includes Disadvantaged Business Enterprises (DBEs). Consistent with Sound Transit Policies and Federal Regulations, Sound Transit has established Small Business/DBE goals for the construction contract. These goals are based upon an examination of subcontracting opportunities contained in the work of this contract and the number of Small Businesses/DBEs available to perform such subcontracting work.

The pre-construction phase of this work does not include a small business goal. An element of the pre-construction phase services is to develop a subcontracting plan for construction. The subcontracting plan will include specific goals for achieving small business utilization based on the type of work and the availability of small and disadvantaged businesses to perform that work.

There is no subcontracting plan at this time as this is a pre-construction contract.

#### **PUBLIC INVOLVEMENT**

The East Link project staff has been actively engaged with stakeholders at all levels throughout the project area. The neighboring communities have had numerous opportunities to meet with staff, learn about the project and provide Sound Transit with comments and questions. The final design has been a collaborative effort between Sound Transit and project stakeholders, including the local community,

the City of Bellevue, the City of Bellevue Citizens Advisory Committee, the Washington State Department of Transportation, King County Transit providers and Emergency service providers.
