

# MOTION NO. M2016-100 Construction Contract for E320 South Bellevue

#### PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Shimmick/Parsons JV to construct the South Bellevue contract E320 within the East Link Extension in the amount of \$321,098,000, with a 12% contingency of \$38,532,000, for a total authorized contract amount not to exceed \$359,630,000.

#### **KEY FEATURES SUMMARY**

- This action will provide for the construction of the South Bellevue Station, Parking Garage, and Light Rail Guideway under the South Bellevue (E320) construction contract.
- The work includes construction of:
  - The South Bellevue Station.
  - Approximately 2.2 miles of elevated, retained cut and at-grade guideway.
  - STart funded artworks on the acoustic panels and art painting at the South Bellevue Station.
  - A new 1,500-stall parking garage will be constructed within the existing over-capacity S.
     Bellevue Park and Ride lot and replace 519 parking stalls.
  - o Reconstruction of 112th Avenue NE over the Light rail guideway.
  - Site improvements for one traction power substation and two signal bungalows.
  - Accommodations for high-rail access to the guideway for maintenance vehicles.
  - Site restoration and related street improvements.
  - Close coordination with WSDOT, City of Bellevue, and King County Metro
- This action includes a request for a 12 percent contingency based upon multiple risks and contract challenges including work over and adjacent to Interstate 90, Bellevue Way, Mercer Slough, creeks, wetlands, and sensitive areas. In addition, the contract includes several interfaces and coordination with private utility owners and has limited adjacent staging areas all of which are consumed by the project improvements.

# **BACKGROUND**

East Link extends light rail 14 miles from downtown Seattle to downtown Bellevue and the Overlake area of Redmond via I-90, with stations serving Rainier Avenue/I-90, Mercer Island, South Bellevue, Downtown Bellevue, Overlake Hospital, the Bel-Red Corridor, Overlake Village, and the Overlake Transit Center. The East Link project route, profiles, and station locations were selected by the Sound Transit Board on July 28, 2011, and amended on April 25, 2013. In April 2015, the Sound Transit Board established the baseline budget and schedule for the project. Revenue service between Seattle and the Overlake Transit Center is forecasted for 2023.


Environmental compliance pursuant to the State Environmental Policy Act (SEPA) for East Link was completed with the East Link Project Final Environmental Impact Statement (EIS) issued on July 15, 2011, and East Link Extension 2013 SEPA Addendum issued March 26, 2013. The Federal Transit Administration and Federal Highway Administration issued a Record of Decision for

the project on November 16, 2011, and November 17, 2011, respectively, completing the National Environmental Policy Act (NEPA) process.

The South Bellevue contract is one of seven major construction contracts for the East Link Extension. Under this contract, the contractor will construct approximately 2.2 miles of elevated, retained cut and at-grade guideway, the elevated South Bellevue Station, 1500-stall parking garage, and other site improvements from Interstate 90 to Bellevue Way SE/112th Avenue NE adjacent to the Mercer Slough Nature Park.

Sound Transit issued an Invitation for Bids (IFB) on May 26, 2016, and four bids were received on August 17, 2016. The bids ranged from \$321,098,000 to \$365,410,000. The low bid of \$321,098,000 is \$44,631,000 or about 12 percent below the Engineer's Estimate of \$365,729,000. Shimmick/Parsons JV is the lowest responsive and responsible bidder with a bid price of \$321,098,000.

#### FISCAL INFORMATION

This action is within the Adopted Budget and sufficient funds remain after approval of this action to fund the remaining work in the Construction Phase for East Link Extension project and for Link East King County Subarea for ST*art* Program as contained in the current cost estimates for both projects.

The proposed contract with Shimmick/Parsons JV for the amount not to exceed \$359,630,000 will provide the construction of the South Bellevue Station, Parking Garage, and Light Rail Guideway in the South Bellevue (E320) that encompasses both East Link Extension and the ST*art* Program as follows:

East Link Extension for an amount not to exceed \$358,631,000 (\$320,099,000 plus \$38,532,000 contingency) and ST*art* Program for an amount not to exceed \$999,000 with no contingency for a contract total of \$359,630,000.

# **East Link Extension**

The 2016 Lifetime Adopted Budget for East Link Extension project is \$3,677,150,000. Within that amount \$1,182,202,000 has been set aside for South Bellevue to SR-520 segment in the Construction Phase. The proposed action would commit \$358,631,000 of this amount leaving the remaining uncommitted budget of \$666,240,092 in the South Bellevue to SR-520 segment in the Construction Phase.

# STart Program

The 2016 Lifetime Adopted Budget for STart Program project is \$49,267,267. Within that amount \$17,956,984 has been set aside for Link transit mode under East King County Subarea. The proposed action would commit \$999,000 of this amount leaving the remaining uncommitted budget of \$15,837,229 for Link transit mode under East King County Subarea.

## **PUBLIC INVOLVEMENT**

Extensive public outreach efforts have taken place on behalf of the East Link Extension over the last nine years. Outreach activities have included meetings with community members, property owners, businesses, stakeholders, local jurisdictions, and agencies. Since the project kickoff in 2006, Sound Transit has hosted approximately 60 public meetings, and has also held hundreds of briefings with property owners and stakeholders; including 82 in 2014. Additionally, project staff have held quarterly meetings with the leadership group for the residential neighborhoods in order to keep them regularly updated on project status and upcoming milestones.

## TIME CONSTRAINTS

This contract is on the near critical path of East Link. The schedule of this contract impacts one major follow-on contract package. A one-month delay in issuing this contract would increase the risk of impacting the critical path of East Link.

#### **MOTION NO. M2016-100**

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute a contract with Shimmick/Parsons JV to construct the South Bellevue contract E320 within the East Link Extension in the amount of \$321,098,000, with a 12% contingency of \$38,532,000, for a total authorized contract amount not to exceed \$359,630,000.
