

MOTION NO. M2016-11 Snow and Ice Removal Services for Winter Inclement Weather

PROPOSED ACTION

Authorizes the chief executive officer to execute a one-year contract with three one-year options with Action Services Corporation to provide snow and ice removal services for winter inclement weather for a total authorized contract amount not to exceed \$662,982.

KEY FEATURES SUMMARY

- This action will provide Sound Transit the labor and equipment necessary to provide on-call snow and ice prevention and removal services.
- The scope includes mechanical and manual snow clearing, plowing, application of ice melt and sand on train passenger platforms, bus transit centers, and vehicle areas. Work is performed using a work order and is initiated within a two-hour time window.
- The contracted service will be provided at Sounder, ST Express, and Tacoma Link facilities as well as at Sound Transit offices located in Pierce, King, and Snohomish counties. The contract also allows for additional sites as needed.
- The requested amount covers the first contract year plus the three one-year options.

BACKGROUND

To maintain safe and accessible facilities, additional staff and equipment is required during winter inclement weather to treat and remove snow and ice. Due to rapidly changing and often highly unpredictable weather patterns, the need for snow clearing, de-icing and/or sanding services may be urgent and may be needed at any time of day or night. Sound Transit does not have enough inhouse facility staff members or the equipment needed to meet the demands of severe or prolonged inclement weather.

The contracted service for snow and ice removal will be provided at Sounder, ST Express, and Tacoma Link facilities as well as at Sound Transit offices located in Pierce, King, and Snohomish counties. Link facilities are maintained under a third-party agreement administered by the King County Light Rail Division.

A winter season event is an event that requires the physical removal of snow or the prevention of snow and ice accumulation. The request for contract authority is based on historical winter season event costs, escalated to reflect current prevailing wages and materials, and additional stations and facilities. The request covers the possibility of three winter season events a year with a duration of two to three days each and 20 frost and ice events per year. Some winters may be mild with few events and only minimal services required. There are no services scheduled for this contract; work is on-call, as needed. Billing occurs only when services are rendered.

A request for proposals was issued in August 2015. Just one proposal was received. Action Services Corporation's pricing was determined to be reasonable, the proposal responsive, and the firm responsible. Action Services is a maintenance and landscaping company with sufficient staff to respond to winter weather emergencies.

FISCAL INFORMATION

The proposed action will be funded from the contract maintenance budget within the Operations Department annual operating budget. The 2016 contract maintenance budget is \$28,915,263. Within that amount, \$48,370 is committed to winter services. Anticipated spending for 2016 under the proposed action is \$45,100, which includes one winter season event, due to the mild 2015/2016 predicted winter.

The proposed action is within the Adopted 2016 Budget and sufficient monies remain after approval of this action to fund other contract maintenance work as contained in the 2016 cost estimates. Spending beyond 2016 will be included in the future annual budgeting cycle.
