## **PROPOSED ACTION**

Authorizes the chief executive officer to execute the University of Washington Station Agreement.

#### **KEY FEATURES SUMMARY**

- The Master Implementation Agreement between the University and Sound Transit (MIA)
  contemplated future operating agreements to cover issues relating to Sound Transit's
  operations such as insurance, safety, and security.
- The proposed University of Washington Station (UW) Agreement covers general operations and maintenance requirements at the station, particularly the surface level plaza area.
   Magnetic field and vibration monitoring is covered in a separate agreement.
- Specifically, this agreement includes terms relating to Sound Transit maintenance of its
  facilities and the plaza, special event coordination, UW logo licensing, and supplements
  previous agreements between the parties relating to utilities. Sound Transit will be responsible
  for plaza maintenance.
- This agreement satisfies the MIA requirement for an operating agreement covering insurance, safety and security prior to revenue service of the University Link Extension.

#### **BACKGROUND**

University Link Extension is a 3.15-mile light rail extension located entirely underground with tunnels traveling east from Pine Street, under the I-5 freeway to an underground station at Capitol Hill, continuing north beneath SR 520 and the Lake Washington Ship Canal to an underground station on the UW campus, located near Husky Stadium.

In 2000, Sound Transit and the UW entered into a Memorandum of Agreement (MOA) relating in general to Sound Transit's right to access UW property to construct and operate a light rail transit system. In 2007, Sound Transit and the UW entered into a Master Implementation Agreement (MIA), which established terms and conditions, regarding access to and use of UW property for purposes of constructing, operating, monitoring, and maintaining the light rail transit system.

The MIA anticipated that Sound Transit and the UW would enter into follow-on agreements to support a range of design, construction, and operations functions. In 2007, the University also granted Sound Transit transportation easements for two light rail segments on UW property: University Link (Segment 1) comes from the south and ends at the northern end of the University of Washington Station, and Northgate Link (Segment 2) goes north from the University of Washington Station and travels in a northwesterly direction under the UW campus.

The proposed University of Washington Station Agreement details maintenance, security, insurance, and event coordination responsibilities. The agreement covers general operations and maintenance requirements at the station, particularly the surface level plaza area. The agreement also includes terms relating to special event coordination utilities, and UW logo licensing. Sound Transit will be responsible for plaza maintenance.

## FISCAL INFORMATION

The proposed action will be funded from the purchased transportation services within the Link annual operating budget. The 2016 purchased transportation services budget is \$37,094,526.\* Within that amount, \$6,400,000 is committed to facilities maintenance. The Board adopted the 2016 operating budget in December 2015.

Estimated costs for the future years of the contract will be included in annual budgeting cycles beyond 2016.

#### PRIOR BOARD/COMMITTEE ACTIONS

Motion No. M2014-35: Authorized the chief executive officer to execute an amendment to the Master Implementation Agreement with the University of Washington to establish new vibration and magnetic field level thresholds that Sound Transit will meet during operation of light rail transit under University property, confirms the University's approval of the University Link and Northgate Link Extensions final design, mitigation plan, and monitoring plan, and includes compensation to the University of Washington in the amount of \$43,300,000 to relocate or otherwise mitigate anticipated impacts to sensitive research labs and activities.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute the University of Washington Station Agreement.
