Contract for Tacoma Link Light Rail Vehicle Truck Assembly Rebuild Services

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with UTCRAS, Inc. to rebuild seven Tacoma Link light rail vehicle truck assemblies for a total authorized contract amount not to exceed \$317,592.

KFY FFATURES SUMMARY

- This action will authorize a midlife maintenance overhaul of Tacoma Link light rail vehicle (LRV) truck assemblies. The overhaul will extend the vehicles useful life another 15 years.
- The scope of work includes replacement of all gaskets, bearings, wheels, brake discs, and inspection of gears and axles of the truck assembly.
- Tacoma Link has a spare truck assembly that will be overhauled first and used as a replacement as truck assemblies are shipped to UTCRAS, Inc. for rebuild; each rebuild will take approximately three months to complete. No service impacts are expected.

BACKGROUND

Tacoma Link light rail began revenue service in August 2003 and operates three Skoda light rail vehicles (LRVs) on 1.6 miles of alignment. Two light rail vehicles are needed for service; one is a rotational spare. The LRV fleet was built in 2001 and have been operating for more than 15 years (including two years of testing and pre-revenue service). The fleet has an average of 375,000 miles per vehicle. According to manufacturer's specifications, the vehicles are now scheduled for a midlife maintenance overhaul. The overhaul consists of extensive diagnostic inspections, rebuilding of components, and replacement parts.

Sound Transit does not have the special tools and equipment necessary to perform the truck assembly overhaul work and purchasing them would be cost prohibitive.

Tacoma Link's maintenance department will remove, ship, and reinstall the rebuilt units. The rebuild will take about three months per truck and approximately two years in total to complete the project.

The project will extend the life of the vehicles for an additional 15 years.

Sound Transit issued an invitation to bid for the truck assembly overhaul work in December 2015 and received two bids. UTCRAS, Inc. was the lowest qualified bidder. UTCRAS, Inc. is based in Morton, Pennsylvania and specializes in all aspects of heavy and light rail truck rebuild and overhaul. The company is certified in wheel, axle, bearing, truck, gearbox, and transmission manufacturing and remanufacturing by the Associations of American Railroads (AAR).

FISCAL INFORMATION

This action is within the adopted budget and sufficient funds remain after approval of this action to fund the remaining work in the Vehicles Phase as contained in the current cost estimates.

The 2016 Lifetime Budget for Tacoma Link LRV Overhaul project is \$731,058. Within that amount, \$665,058 has been set aside for the Vehicles Phase; \$0.00 has been committed for the Vehicles Phase.

The proposed action would commit \$317,592 for UTCRAS, Inc. contract to provide rebuild services for the truck assembly leaving the remaining uncommitted budget of \$347,466 in the Vehicle Phase.

Sound Transit promotes and encourages small business participation, which also includes Disadvantaged Business Enterprises (DBEs). Small Business and DBE goals are based upon an examination of subcontracting opportunities contained in the work of this contract and the number of Small Businesses/DBEs available to perform such subcontracting work.

Sound Transit determined that there were few Small Business and DBE subcontracting opportunities based upon the work described in this contract, so Small Business/DBE goals were not established or required.
