Contract for Design and Construction Services for Puyallup Station, Sumner Station and Kent Station Platform Lighting Upgrade Projects

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Ameresco Quantum, LLC to provide design and construction services for the Puyallup Station, Sumner Station, and Kent Station Platform Lighting Upgrade projects for a total authorized contract amount not to exceed \$548,000.

KEY FEATURES SUMMARY

- The Puyallup Station, Sumner Station, and Kent Station Platform Lighting Upgrade projects were created in the 2016 budget for the installation of energy efficient lighting.
- Upon completion of the three projects, the agency will be eligible for a combined utility incentive of \$67,148 and realize additional savings in reduced utility consumption, lower maintenance costs and a longer life for fixtures.
- The scope of work includes design, construction, installation and verification of energy reduction measures for the lighting systems at Puyallup Station, Sumner Station, and Kent Station Platform. Installation features include LED (light emitting diode) fixtures, photo cell controls and occupancy sensors.
- The Sound Transit contract would "piggyback" on the State of Washington, Department of Enterprise Services Master Contract with Ameresco Quantum, LLC within their Energy Savings Performance Contracting program.

BACKGROUND

In 2013, Sound Transit initiated LED retrofits at several locations. These projects demonstrated utility and maintenance savings of approximately 25-35% per year compared to the old fixtures.

During 2014 the Facilities Division had energy performance audits performed at four additional sites as part of Sound Transit's Sustainability Plan to reduce energy consumption. The three sites in this request were identified as having adequate energy savings to justify the upgrade, along with the additional benefit of replacing aging, high maintenance lighting systems.

Based on the agency's experience at sites that were previously retrofit, the extended life of the LED lighting components will reduce maintenance costs by approximately \$15,000 per year. The energy-cost savings for all three sites is estimated to be \$31,082 per year and will be monitored by Ameresco Quantum, LLC after the first year to verify actual savings.

In addition to energy-cost savings, the upgrades allow the agency to leverage an additional \$67,148 from a one-time utility incentive.

These three Lighting Upgrade Projects adopted in 2016 were coupled with anticipated 2017 energy projects at the Link Operations Maintenance Facility (OMF). The combined set of projects allowed Sound Transit to apply for and receive a State of Washington Department of Commerce Energy Grant in the amount of \$350,000 to defray the cost of these energy efficient improvements. The Agency would be eligible to submit for the grant funds when all current and proposed 2017 energy improvement projects are complete.

The Ameresco Quantum, LLC contract is project specific and will expire upon Sound Transit's final acceptance.

FISCAL INFORMATION

This action is within the adopted project budget(s) as contained in the current cost estimates.

LED lighting retrofit actions have proven to be cost efficient projects resulting in savings or reduced cost increases to Sound Transit.

The project budgets in the 2016 Transportation Improvement Plan (TIP) for the three projects affected by this action are as follows:

- a) Puyallup Station LED lighting is \$178,050.
- b) Sumner Station LED Lighting is \$134,140.
- c) Kent Station Platform Lighting is \$236,173.

The total cost of the contract is split into each project at 32.5%, 24.5% and 43% respectively and includes both design work budgeted under the preliminary engineering phase and construction/installation of the lighting systems.

The projected net cost to the Agency for the installed lighting system(s) less incentives and grant is \$360,852

Estimated Annual Utility Cost & Maintenance Savings - \$46,082

Simple break-even payback – 7.8 years

There is no contract contingency as previous experience with the contractor requires none.
