Procurement and Installation of a Light Rail Vehicle Lift at the Link Operations and Maintenance Facility

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Macton Corporation to procure and install a second lift in the Link Operations and Maintenance Facility in the amount of \$630,000, with a 10% contingency of \$63,000, for a total authorized contract or agreement amount not to exceed \$693,000 plus applicable taxes, contingent upon resolution of any protest received.

KEY FEATURES SUMMARY

- A second light rail vehicle lift is needed at the Link Operations and Maintenance Facility (OMF)
 to accommodate peak vehicle requirements for additional ST2 service and the corresponding
 increased maintenance required resulting from higher than anticipated ridership, and vehicle
 usage.
- One vehicle lift is insufficient for current and future maintenance needs, including the mid-life overhaul for the fleet beginning in 2018.
- The scope of work includes the design, installation, testing and commissioning of an above ground lift including all control systems, wiring, and turn tables.
- The manufacturer will provide all the warranties, training and spare parts associated with this supply and install contract.
- Applicable taxes are currently estimated to be \$69,993.

BACKGROUND

Sound Transit currently has a fleet of 62 light rail vehicles. Thirty-one were originally procured for Sound Move in 2003, with an option for 31 more. In 2005, four were procured for the extension to Sea-Tac Airport, and 27 were procured in 2008 to support the Sound Move University Link extension, the ST2 Angle Lake extension, and future ST2 service adds.

One vehicle maintenance lift was installed when the OMF was built in 2007. A second lift is needed for vehicle maintenance, both scheduled and unscheduled. The additional lift will support the midlife overhaul for the fleet beginning in 2018.

Macton Corporation is expected to complete the lift design and fabrication of the lift by second quarter 2018. Sound Transit, in collaboration with Macton Corporation and Sound Transit consultant, will design the foundation and required utilities. Sound Transit will procure a separate construction contract to construct the foundation and supply the electrical panels. If the construction contract exceeds the CEO's authority, staff will return at a future date to request Board approval. The construction work is expected to be completed by third quarter 2018. After construction, Macton Corporation will install, test, and commission the lift. Link light rail anticipates being able to use the lift by fourth quarter 2018.

PROCUREMENT INFORMATION

An Invitation for Bid (IFB) was issued on July 13, 2017. Two bids were received. The bid from Macton Corporation was determined to be the lowest responsive and responsible bid. Therefore, contract award is recommended to Macton Corporation.

FISCAL INFORMATION

The authorized project allocation to date for the Link Operations & Maintenance Facility light rail vehicle (LRV) Lift is \$4,898,160. Within that amount \$3,684,240 has been allocated for the construction phase. The proposed action would commit \$762,993 to this phase, leaving a remaining uncommitted budget balance of \$2,919,661.

This action is within the authorized project allocation to date and sufficient monies remain after approval of this action to fund the remaining work in the construction phase.
