PROPOSED ACTION

(1) Authorizes the chief executive officer to execute a contract with MCI Sales and Service, Inc. to provide bus rebuild services in the amount of \$229,711, with a 10% contingency of \$22,971, for a total authorized contract amount not to exceed \$252,682 plus applicable taxes, and (2) supersedes Motion No. M2017-133.

KEY FEATURES SUMMARY

- At the November 2, 2017 Operations and Administration Committee meeting, the Committee approved Motion No. M2017-133 to execute a contract with Motor Coach Industries, Inc. to perform bus rebuild services. The contractor name in the action should have been MCI Sales and Service, Inc., the contractor's legal name. This motion will supersede Motion No. M2017-133 and authorize the CEO to enter into the contract with MCI Sales and Service, Inc. (MCI).
- In October 2016, an MCI bus was damaged by an electrical fire and has been inoperable since.
- The bus operated from Pierce Transit's Lakewood base and is needed to maintain an adequate fleet size for Pierce and South King County service.
- The most cost effective action is to rebuild this bus rather than replace it.
- The rebuild contract amount includes transportation to and from MCI's shop in Des Plaines, Illinois.
- Applicable taxes are currently estimated to be \$23,201.

BACKGROUND

On October 13, 2016 a Sound Transit 2005 MCI over-the-road coach was on the bus base being prepped for revenue service when an electrical fire started in an electrical compartment located above and behind the operator's seat. While the fire was extinguished quickly, it resulted in moderate heat-related damage to the driver's area and smoke damage inside the bus.

An investigation into the cause of the fire found it to be the result of a faulty electrical switch. Subsequently all MCI buses in Sound Transit's fleet were examined, and where this model of switch was found, a new model was substituted. No further events have occurred.

An independent appraiser hired by Washington State Transportation Insurance Pool (WSTIP) estimated the cost of repairs to the bus to be \$220,224. The proposed price from MCI for repairs is \$229,711, or 4.3 percent higher than the appraiser's estimate. This is a reasonable variance given the complexity of the repairs. Per Sound Transit's fleet replacement policies, the bus has at least four more years of useful life. The insurance pool estimated that the remaining value of the bus (less deductible and salvage value) was \$106,812 and compensated Sound Transit in that amount.

The net cost to Sound Transit if the bus is repaired would be \$122,899, taking into consideration insurance proceeds. Annualized over four years that cost would be \$30,725 a year. The cost for a

new bus would be approximately \$850,000, annualized over the 15 years lifespan of the bus, that would be \$56,667 a year. The net cost to Sound Transit is lower if repairs are done, and the rebuild avoids the operational issues of a one bus sub-fleet.

PROCUREMENT INFORMATION

Sound Transit issued a Request for Proposals for rebuild services for a fire-damaged bus on May 19, 2017. One proposal was received from MCI with a follow-up best and final offer. The BAFO was lower than the original bid. A price/cost analysis was performed to determine that the price was fair and reasonable.

FISCAL INFORMATION

The proposed action will be funded from the Purchased Transportation Services within the Operations Department annual operating budget. Sufficient funds are available in 2017 Purchased Transportation Services within the Operations Department to fund any unanticipated 2017 expenses associated with the execution of this contract.

Given the uncertainty of executing and completing the contract within 2017, the Operations 2018 Proposed Budget includes the estimated cost of \$252,682 for the bus rebuild. The proposed budget will be presented to the Board through the annual budget development process beginning in November.

A motion of the Operations and Administration Committee of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer (1) to execute a contract with MCI Sales and Service, Inc. to provide bus rebuild services in the amount of \$229,711, with a 10% contingency of \$22,971, for a total authorized contract amount not to exceed \$252,682 plus applicable taxes, and (2) supersedes Motion No. M2017-133.
