Operations and Maintenance Agreement with WSDOT during Light Rail Construction in the I-90 Corridor within the East Link Extension

PROPOSED ACTION

Authorizes the chief executive officer to execute an Operations and Maintenance Agreement with the Washington State Department of Transportation to define maintenance responsibilities, purchase specialized vehicles, and provide payment for certain maintenance services during light rail construction in the I-90 corridor as part of the East Link Extension for a total authorized agreement amount not to exceed \$2,390,000.

KEY FEATURES SUMMARY

- The Operations and Maintenance Agreement outlines Sound Transit's and the Washington State Department of Transportation's (WSDOT's) respective responsibilities for maintenance of the I-90 right-of-way during construction of the East Link Extension.
- The O&M Agreement will run concurrently with the 73-month Temporary Construction Airspace Lease for the construction of the I-90 portion of the East Link Extension.
- Under the agreement, Sound Transit will pay WSDOT the following not to exceed amounts:
 - \$60,000 to purchase three maintenance vehicles for revised access to the Homer M.
 Hadley Bridge to increase safety for WSDOT's maintenance staff. WSDOT will maintain, repair, and replace vehicles as needed.
 - \$200,000 per year to reimburse WSDOT for net cost increases to maintain the outer roadways of the I-90 corridor for traffic use, due solely to the new outer roadway lane and shoulder layout. Actual costs, if any, are subject to verification and concurrence by Sound Transit.
 - \$350,000 per biennium toward the shared cost of required maintenance and verification inspections of the Homer M. Hadley Bridge and approach spans.
 - \$80,000 toward the shared cost of an in-depth electrical and mechanical inspection of the Homer M. Hadley Bridge and approach spans.

BACKGROUND

East Link extends light rail 14 miles from downtown Seattle to downtown Bellevue and the Overlake area of Redmond via I-90, with stations serving Rainier Avenue/I-90, Mercer Island, South Bellevue, Downtown Bellevue, Overlake Hospital, the Bel-Red Corridor, Overlake Village, and the Overlake Transit Center. The East Link project route, profiles, and station locations were selected by the Sound Transit Board on July 28, 2011, and amended on April 25, 2013. Light rail service between Seattle and the Overlake Transit Center is forecasted to begin in 2023.

In 2012, Sound Transit and WSDOT entered into an Umbrella Agreement to outline the process that would lead to a lease of the existing center roadway portion of I-90 for the East Link Extension Project. Sound Transit and WSDOT also entered into a Temporary Construction Airspace Lease

and Permanent Airspace Leases in 2012. Sound Transit will construct the East Link improvements under a Temporary Construction Airspace Lease.

The Operations and Maintenance Agreement identifies maintenance responsibilities between the two agencies during light rail construction in the I-90 corridor. The agreement identifies and covers specific costs that WSDOT may incur as a result of the East Link Extension during construction, and sets forth the cost sharing for such maintenance.

FISCAL INFORMATION

This action is within the baseline budget and sufficient funds remain after approval of this action to fund the remaining work in the Third Party phase as contained in the current cost estimates.

The baseline budget for the East Link Extension project is \$3,677,150,000. Within that amount, \$52,150,000 has been set aside for the Third Party phase. Of that amount \$36,951,232 has been previously committed. The proposed action would commit \$2,390,000 for the O&M Agreement with WSDOT during light rail construction in the I-90 corridor leaving a remaining uncommitted budget of \$12,808,768 in the Third Party phase.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute an Operations and Maintenance Agreement with the Washington State Department of Transportation to define maintenance responsibilities, purchase specialized vehicles, and provide payment for certain maintenance services during light rail construction in the I-90 corridor as part of the East Link Extension for a total authorized agreement amount not to exceed \$2,390,000.

BACKGROUND:
