PROPOSED ACTION

Authorizes the chief executive officer to execute a one-year contract for landscaping services with AtWork!, with four one-year options to extend for a total authorized contract amount not to exceed amount of \$1,500,000.

KEY FEATURES SUMMARY

- The proposed action authorizes a new contract with Atwork! for landscaping services.
- The scope of work includes regular scheduled mowing, edging, pruning, trimming and trash
 pickup as well as unscheduled landscaping including plant replacement, plant removal and
 arborist services.
- The contract covers properties maintained by Sound Transit that are not currently being used for construction or revenue service. Landscaping services for properties in revenue service are covered under a separate contract. The number of properties to be maintained will increase over the next five years as new properties are acquired for ST2 and ST3.
- The amount requested covers the one-year term and the four one-year options to extend the contract. Work will be authorized on a task order basis.

BACKGROUND

Sound Transit currently manages and maintains over 24 miles of railroad right of way and 350 properties that are being held until construction begins, are not in revenue service or are awaiting further action.

The contractor will perform landscape maintenance to ensure Sound Transit properties are maintained in a neat and orderly manner.

Due to the number of properties, specialized equipment, additional vehicles, parking, and storage necessary for said equipment, outsourcing is the most economical means to maintain the properties.

PROCUREMENT INFORMATION

The Request for Proposal (RFP) was advertised in January 2017 and there were 10 proposals received. These firms were all local and are small businesses. AtWork! was the top-ranked firm offering the best value to Sound Transit.

FISCAL INFORMATION

The proposed action will be funded from the Services category within the Design, Engineering and Construction Management (DECM) department's annual operating budget. The Services category

budget is \$2,461,850, of which a total of \$175,000 is estimated to be spent in the current year for the contract and is within the agency's budget authority.

After approval of this action, the remaining annual budget amount will be used to fund other department expenditures anticipated in the 2017 annual budget.

Funding for the additional years of the contract will be included in future annual budget requests.

PUBLIC INVOLVEMENT

TIME CONSTRAINTS

A one-month delay would have a significant impact on the number of properties that Sound Transit will be able to maintain until this contract is authorized. Property Management would need to stop

landscaping work on Sound Transit owned properties as there will be no funds left in the current contract by the end of May. Maintaining properties is of the upmost importance in this time of the year as vegetation is growing.
