#### Increase Contingency for U District Station Finishes Contract

## **Proposed action**

Authorizes the chief executive officer to increase the contract contingency for the U District Station Finishes contract with Hoffman Construction for the Northgate Link Extension in the amount of \$7,500,000, for a new total authorized contract amount not to exceed \$175,328,522.

## Key features summary

- The contract for U District Station Finishes is progressing on schedule and approximately 78 percent of the work completed to date. Over the first 29 months of the contract, changes were required that used approximately 90 percent of the initial contract contingency. The largest changes included:
  - Addition of a public stairway to the platform level to enhance pedestrian access and circulation.
  - New code, regulatory, or other third party requirements such as the 2017 sales tax increase and energy recovery measures.
  - Changes initiated by Sound Transit to improve station control and monitoring systems including emergency ventilation systems and fire life safety resulting from "lessons learned" on the operation of the U-Link alignment.
- Estimates to complete the contract indicate that additional funds in the amount of \$7,500,000 are necessary to fund the changes that are anticipated through contract completion.
- This additional contingency will bring the total authorized contingency to \$15,491,834, or 9.7 percent of the original contract amount.

## Background

The Northgate Link Extension extends light rail approximately 4.3 miles from the University of Washington Station to the Northgate neighborhood. The U District Station is located on 12th Avenue NE and NE 65th Street and is one of two underground stations for the Northgate Link Extension. The Northgate Link Extension is scheduled to be completed in September 2021 and will provide an interim terminus for Link light rail at Northgate until the Lynnwood Link Extension is operational.

The U District Station Finishes contractor, Hoffman Construction, began work on site in July 2017 and is currently 78 percent complete. Hoffman has completed the main structure for the underground station

and is progressing with the buildout of the various subsurface levels and the two above ground head house entrance structures.

The addition of the public staircase from the mezzanine level to the platform level at the station will enable passengers to access the station platform all the way from the surface without having to use escalators or elevators. In addition to the added public staircase, other changes required to-date have included the following:

- New code, regulatory, or other third party requirements such as the 2017 Sales Tax increase and energy recovery measures associated with escalators.
- Changes initiated by Sound Transit to improve station control and monitoring systems, including the Emergency Ventilation System.
- Site access constraints resulting from the tunnel contractor's delays in accommodating the station contractor unrestricted use of work areas.

## Procurement information

The U District Station Finishes contract uses the GC/CM contracting method, an alternative method allowed under RCW 39.10. The Project Review Committee of the State's Capital Project Advisory Review Board approved the GC/CM method for this project in 2012.

A Request for Qualifications was issued in October 2013 and four Statements of Qualifications (SOQs) were received. Following review and evaluation, three firms were invited for interviews. Based on scoring of the SOQs and the interviews, all three firms were asked to submit final proposals including price offers for specified work items. The price offers were opened publicly on March 10, 2014. Based on evaluation of SOQs, interviews, and price offers, Hoffman Construction was the highest ranked firm. Preconstruction Services commenced July 2014.

Consistent with the GC/CM process, Sound Transit negotiated a Maximum Allowable Construction Cost (MACC) with the contractor, and subsequently a Total Construction Cost (TCC) of \$159,836,688 was established for the contract. This amount, plus a five percent contingency, was approved by the Sound Transit Board in March 2017.

## **Fiscal information**

This action is within the baseline budget and sufficient monies remain after approval of this action to fund the remaining work in the construction phase as contained in the current cost estimates.

The baseline budget for the Northgate Link Extension is \$1,899,755,500. Within the construction phase, \$175,500,000 has been allocated to the budget line item for N140 U District Station Finishes. The

proposed action would commit an additional \$7,500,000 to this line item and leave a remaining budget balance of \$171,478.

## Public involvement

The Northgate Link Extension maintains an active public involvement program to keep affected communities informed about facility design and construction plans.

Project staff meet with affected neighborhood and business groups, property owners, businesses and individuals as needed to provide project updates and respond to questions and concerns about the project. Additional meetings are also held with third party stakeholders to keep them informed on project progress. An electronic project newsletter is sent out to over 3,000 people on the project e-mail list to keep the interested public informed about project activities and upcoming community meetings.

#### **Time constraints**

A one-month would not create a significant delay to the overall project schedule.

#### **Prior Board/Committee actions**

<u>Motion No. M2017-31</u>: Authorized the chief executive officer to execute a construction contract with Hoffman Construction Company to construct the U District Station Finishes within the Northgate Link Extension in the amount of \$159,836,688 with a 5% contingency of \$7,991,834 for a total authorized contract amount not to exceed \$167,828,522.

<u>Motion No. M2014-41</u>: Authorized the chief executive officer to execute a contract with Hoffman Construction Company to provide pre-construction services for U District Station Finishes within the Northgate Link Extension in the amount of \$1,475,335, with a contingency of \$100,000, for a total authorized contract amount not to exceed \$1,575,335.

## Motion No. M2019-101

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to increase the contract contingency for the U District Station Finishes contract with Hoffman Construction for the Northgate Link Extension in the amount of \$7,500,000, for a new total authorized contract amount not to exceed \$175,328,522.

#### Background

The Northgate Link Extension extends light rail approximately 4.3 miles from the University of Washington Station to the Northgate neighborhood. The U District Station is located on 12th Avenue NE and NE 65th Street and is one of two underground stations for the Northgate Link Extension. The U District Station Finishes contractor, Hoffman Construction, began work on site in July 2017 and is currently 78 percent complete. It is hereby moved by the Board of the Central Puget Sound Regional Transit Authority that the chief executive officer is authorized to increase the contract contingency for the U District Station Finishes contract with Hoffman Construction for the Northgate Link Extension in the amount of \$7,500,000, for a new total authorized contract amount not to exceed \$175,328,522.
