Summary – Information Security Governance

Scope

Examined the agency's oversight process and management controls in place as of March 2020.

Results

Commend: Sound Transit has improved the InfoSec Program Maturity level from 0 to a maturity level of 3.5 in a four year period

Finding: Information Security Governance has not been formally defined at the Agency

Management Response – Information Security Governance

- Information Security agrees with the findings and observations noted.
- Currently, InfoSec is strengthening communication, reporting, and monitoring controls that support information security governance and risk management.
- Evaluating and implementing the appropriate level of executive oversight.







Summary – Consultant On & Off Boarding Practices

Scope

Examined consultant, contractor and extranet user records from January 1, 2017 to April 15, 2020.

Results

Finding: The Agency lacks effective consultant onboarding and off-boarding processes.

- * Policies, procedures, and processes are inconsistent
- * Users are not off-boarded properly



Management Response – Consultant On and Off-Boarding Practices

- Agency management agrees with the finding and observations noted.
- Created a process for deactivation of building access for inactive and temporarily inactive consultants.
- Created a tracking system for mandatory COVID-19 training for consultants with need to work onsite at the Sound Transit campus
- Created a cross-functional task force to identify process and control improvement areas.
