Proposed action

Authorizing phase transfers for certain System Expansion, Enhancement and State of Good Repair projects while maintaining the authorized project allocation established for each project.

Key features summary

- This action would reallocated funds between project phases for one System Expansion project, four State of Good Repair projects and five Enhancement projects. There is no increase to the project allocations for any of the projects.
- This action is needed because these projects have spending or forecasted spending in phases where there is no budget or insufficient budget. Project phases include Agency Administration, Preliminary Engineering, Final Design, Construction and Construction Services and are used to track planned spending within the total project budget.
- The action would amend the individual project budgets to transfer money between phases as follows:

 Board action is needed to allow work to proceed and to remain in compliance with the Board's budget policy.

Background

The Board's budget policy, Resolution No. R2018-32, requires that the Board approve budget transfers between project cost phases of the same project, except for the one-time actions the CEO is authorized to take to create the final adopted budget book.

These transfers will allow project work to advance or will transfer budget into the appropriate categories to complete project work. There is no increase to any project allocations to date for any of the projects.

Project status

Project scope, schedule and budget summary for the Sounder Maintenance Base are located on page 153-155 of the September 2020 Agency Progress Report.

Fiscal information

The following projects are projected to overspend the authorized project allocation by phase. There is no change to the authorized project allocation per project. There are 2020 spending in these phases, however, it does not exceed the authorized project allocation of the project and the annual cap of the project type.

Resolution No. R2020-25

A RESOLUTION of the Board of the Central Puget Sound Regional Transit Authority authorizing phase transfers for certain System Expansion, Enhancement and State of Good Repair projects while maintaining the authorized project allocation established for each project.

WHEREAS, the Central Puget Sound Regional Transit Authority, commonly known as Sound Transit, was formed under chapters 81.104 and 81.112 of the Revised Code of Washington (RCW) for the Pierce, King, and Snohomish Counties region by action of their respective county councils pursuant to RCW 81.112.030; and

WHEREAS, Sound Transit is authorized to plan, construct, and permanently operate a highcapacity system of transportation infrastructure and services to meet regional public transportation needs in the Central Puget Sound region; and

WHEREAS, in general elections held within the Sound Transit district on November 5, 1996, November 4, 2008, and November 8, 2016, voters approved local funding to implement a regional high-capacity transportation system for the Central Puget Sound region; and

WHEREAS, through Resolution No. R2019-30 the Board adopted the annual 2020 Budget and the Transit Improvement Plan; and

WHEREAS, the adopted 2020 budget includes System Expansion projects to expand the regional transit system through the planning, design, and construction of light rail, commuter rail, express bus, and bus rapid transit infrastructure; and

WHEREAS, the adopted 2020 budget includes State of Good Repair projects to invest in transit system assets to insure the expected useful life is achieved, extend the useful life, and replace assets as needed; and

WHEREAS, the adopted 2020 budget includes Enhancement projects to improve operating efficiency and effectiveness, improve rider experience, increase system functionality, or reduce operating costs; and

WHEREAS, some State of Good Repair projects and Enhancement projects have 2020 spending or forecasted 2020 spending in phases where there is no budget or insufficient annual budget, while there is still sufficient project allocation; and

WHEREAS, the Budget Policy adopted by the Board through Resolution No. R2018-23 requires Board approval to transfer budget between project cost phases of the same project.

NOW, THEREFORE, BE IT RESOLVED by the Board of the Central Puget Sound Regional Transit Authority that the following phase transfers for Enhancement and State of Good Repair projects are approved while the authorized project allocation established for each project is maintained:

- Sounder Maintenance Base Transfer \$110,000 from the Construction phase to the Agency Administration phase
- Downtown Seattle Transit Tunnel Capital Improvements Transfer \$9,129 from the Construction phase to the Right of Way phase
- Wheel Truing Machine Transfer \$157 from the Construction phase to the Agency Administration phase

- Kinkisharyo LRV System Upgrade Transfer \$16,000 from the Final Design phase to the Agency Administration phase
- Puget Sound Emergency Radio Network Transfer \$30,000 from the Preliminary Engineering phase to the Final Design phase
- SeaTac Airport Wrong Door Transfer \$42,047 from the Construction phase to the Final Design phase
- Operations and Maintenance Facility Link Control Center Upgrades Transfer \$40,552 from the Construction phase to the Agency Administration phase
- Operations and Maintenance Facility Renovations Transfer \$10,000 from the Final Design to the Preliminary Engineering phase
- Operations and Maintenance Facility Expanded Parking Transfer \$21,956 from the Final Design phase to the following phases: \$12,809 to the Agency Administration phase and \$9,147 to the Construction phase
- Operations and Maintenance Facility LRV Lift Transfer \$99,762 from the Construction phase to the Agency Administration phase
