Proposed action

Authorizes the chief executive officer to execute an agreement with the City of Shoreline for Sound Transit to contribute funding for right of way acquisition and construction of the NE 145th Street/I-5 Interchange Project, which would construct a westbound transit priority meter for buses of an amount not to exceed \$10,000,000.

Key features summary

- Shoreline will manage the project right of way acquisition and construction responsibilities, with oversight by WSDOT. The agreement includes provisions to ensure Sound Transit's interests are protected upon completion of construction and during operations.
- The westbound transit meter would give priority to Stride and partner transit agency buses entering the NE 145th Street/I-5 Interchange.
- The transit priority meter significantly reduces the length of Business Access and Transit (BAT) lanes required on NE 145th Street.
- The Lynnwood Link Extension construction improvements at NE 145th Street and 5th Avenue NE will be reduced to match the smaller footprint required by the roundabout and existing permits will be revised.
- Shoreline will continue to pursue grant opportunities; which could reduce Sound Transit's contribution.
- The Agreement provides for completion of the Interchange Project by December 31, 2025 and includes an option to extend the completion deadline by up to nine months without additional Board action.

Background


The SR 522/NE 145th Bus Rapid Transit (BRT) Project establishes BRT service along the corridor, primarily operating in business access and transit (BAT) or bus queue bypass lanes for 9 miles between Shoreline and Bothell, with separate, connecting service options to Woodinville. Funding for the SR522/NE 145th Street BRT project was approved by voters in the ST3 Plan. The Board adopted schedule for the project is 2026.

Project development involved planning and preliminary design of BRT elements, including routing, roadway and sidewalk improvements; 12 BRT station pairs between the termini; and parking facilities. The analysis during the Preliminary Engineering phase confirmed the station locations and identified speed and reliability project elements.

Sound Transit issued a State Environmental Policy Act (SEPA) Determination of Nonsignificance (DNS) for the SR 522/NE 145th BRT Project on March 25, 2021.

The Shoreline Interchange Project would replace two signalized intersections on the west (NE 145th Street/I-5 on-off ramps) and east (NE 145th Street/5th Ave NE) sides of the overpass with multi-lane roundabouts, with a westbound transit priority meter for transit entering the roundabout. The Shoreline Interchange Project also improves a shared pedestrian and bicycle path on the north side of the NE 145th Street overpass and provides improved circulation for BRT vehicles accessing and exiting the Shoreline South/NE 148th Street Station. Shoreline issued a SEPA DNS for the Interchange Project on October 15, 2021.

Fiscal information

This action is within the authorized project allocation and sufficient monies remain after approval of this action to fund the remaining work in the third party agreements phase. There are no applicable taxes.

The authorized project allocation for the SR 522-NE 145th St BRT is \$148,570,000. Within the third party agreements phase, \$10,159,000 has been allocated to the budget line item for other third parties. The action would commit \$10,000,000 to this line item and coupled with previous commitments would leave a budget balance of \$25,019.20.

The current cost estimate for the SR 522-NE 145th St BRT project is \$544 million in 2019 dollars and is affordable within the Agency's Finance Plan. This action is in alignment with the program master schedule and current authorized project allocation, and it does not impact the affordability of any other system expansion project.

Sound Transit's funding contribution of up to \$10,000,000 for the NE 145th Street/I-5 Interchange Project is affordable within the Agency's Finance Plan. Staff are managing the SR 522/145th BRT project toward a 2026 delivery, consistent with both Affordable and Target Schedules. This action is in alignment with Resolution No. R2021-05 and does not impact the affordability of any other system expansion project.

The transit priority meter significantly reduces the length of Business Access and Transit (BAT) lanes required on NE 145th Street. The Lynnwood Link Extension construction improvements at NE 145th Street and 5th Avenue NE will be reduced to match the smaller footprint required by the roundabout and existing permits will be revised.

Shoreline will continue to pursue grant opportunities; which could reduce Sound Transit's contribution.

The Agreement provides for completion of the Interchange Project by December 31, 2025 and includes an option to extend the completion deadline by up to nine months without additional Board action.

Motion

It is hereby moved by the Board of the Central Puget Sound Regional Transit Authority that the chief executive officer is authorized to execute an agreement with the City of Shoreline for Sound Transit to contribute funding for right of way acquisition and construction of the NE 145th Street/I-5 Interchange Project, which would construct a westbound transit priority meter for buses of an amount not to exceed \$10,000,000.
