Background

Move Ahead WA Legislation

- State grant funding incentive to transit agencies adopting free Youth fares by October 1, 2022.
- Sound Transit is not eligible for these state grant funds, but free youth fares requires regional participation.

Future Actions

- Authorize daily paid parking Sept
- ☐ Increase Link fares and/or change fare structure (distance-based vs. flat fare) – Sept
- ☐ Establish T Line fares Oct
- Establish Stride fares and set farebox recovery target



Benefits

Over 600,000 Youth eligible for Free Fares


- 77,000 active ORCA Youth cards will become a Free Youth Transit Pass
- Incentivizes Youth ridership
- Aligns ST with the region



Financial Impact

ST not currently eligible for state grants to mitigate loss of youth fare revenue.

- Youth fare currently \$1.50
- In 2019, Youth fare revenue was \$3M (10% paid by UW and 39% by Seattle School Dist.) Youth Fare revenue anticipated to grow to \$9M annually by 2046.
- Free Youth fares reduces fare revenue by \$148M through the life of the financial plan (2046).





Public Input

Public input period was June 2 - 26

- 38 people responded via email
- 2 people attended in-person for the hybrid public hearing
- More than 7,500 social media impressions
- 359 visits to the project web pages
- At least 3 earned media mentions from the press release

Public comment generally supportive



Regional Approach for Implementation

- Common regional language: Free Youth
 Transit Pass
- Implement in partnership with schools
- Goal Everyone taps
- \$500K grant secured to offset costs
