Background

Resolution No. R2016-10

"a new action will be proposed to the Board prior to opening of Tacoma Link Expansion service to establish fare levels"



Schedule

- June 2021: Public Outreach/Feedback
- September 2021: Development of ST Staff Fare Recommendation
- October 2022: Board Briefing and Decision
- Hilltop extension opening: Implementation

- Adult \$2.00 Align with current Pierce Transit Bus Fare
- Adult \$2.25 Align with Link 1 Line Base Fare
 - Note: Link Youth and ORCA LIFT Fares reflect changes effective 9/1/2022

Public Outreach

- Public Notification information on options and how to provide feedback/input

Survey Results

\$2.00 Align with current Pierce Transit Bus Fare \$2.25 Align Adult Fare with Link 1 Line Base Fare

Preferences for Fare Options

- Respondents indicated a preference for the \$2.00 option that aligns with the current Pierce Transit fare on all four measures used in the survey.
 - A higher percentage of respondents found \$2.00 option to be "Easy to Understand"
 - Respondents were twice as likely to find \$2.00 option to be "Equitable for Riders"
 - A higher percentage of respondents found \$2.00 option to be "Affordable for Me"
 - Respondents were more than twice as likely to "Like" \$2.00 option



Revenue

Estimated Revenue from \$2.25 option is \$110K more than \$2.00 option in 2025

Adult Fare	Estimated Annual Revenue (2025)*
\$2.00 (same as current PT fare)	\$1.27 million
\$2.25 (same as Link 1 Line base fare)	\$1.38 million

* Revenue reflects recent fare changes for \$0 Youth fare and \$1 ORCA LIFT fare



Recommendation

Establish Tacoma Link Fare to be \$2 (Adult)

- This fare level allows riders with ORCA cards to make seamless
 Tacoma Link & Pierce Transit transfers
- Public feedback supports this option



Mitigation Plan

- Provide passengers with ORCA cards to make seamless T-Link/Pierce Transit transfers and encourage ORCA adoption – ORCA cards may be provided through Sound Transit Ambassadors, Street Team Events, CBO's and potential direct mailing of ORCA cards to project area households
- Work with community-based organizations, Community Heath Care of Pierce County and DSHS to enroll low-income passengers in the ORCA LIFT program and provide riders with ORCA LIFT cards
- Close coordination with Pierce Transit on implementation of fare
