Agreement with the Cities of Bellevue, Mercer Island, and Redmond to cover costs for Emergency Responder Training and Supplies

Proposed action

Authorizes the chief executive officer to (1) execute an agreement with the cities of Bellevue, Mercer Island, and Redmond for Sound Transit to pay an agreed amount of \$1,527,303 for emergency responder training and equipment needed for the startup of the East Link and Downtown Redmond Link Extensions, and (2) transfer previously purchased emergency responder preparedness equipment.

Key features summary

- Emergency responder training is required for the safety certification and start-up of the East Link and Downtown Redmond Link Extension projects.
- Sound Transit staff worked with the emergency responders within Bellevue, Mercer Island and Redmond to develop an emergency preparedness training plan for East Link and Downtown Redmond Link Extension projects.
- New equipment is needed for emergency responders to provide effective emergency response.
 This agreement transfers ownership of previously purchased Sound Transit equipment to the cities to support emergency responder preparedness.
- The remaining amount for training and equipment was estimated to be \$2,077,303. After deducting \$550,000 for the City of Bellevue's contribution for the firefighter access door (M2023-03), the outstanding balance is \$1,527,303. As part of this agreement, Sound Transit will contribute \$1,527,303 to cover the outstanding balance.
- Emergency responder training to support the system integrated testing was completed in 2021 and the remaining training is scheduled to begin in Spring of 2023.

Background

East Link Extension extends light rail 14 miles from downtown Seattle to downtown Bellevue and the Overlake area of Redmond via I-90, with stations serving Rainier Avenue/I-90, Mercer Island, South Bellevue, Downtown Bellevue, Overlake Hospital, the Bel-Red Corridor, Overlake Village, and the Overlake Transit Center. The East Link project route, profiles, and station locations were selected by the Sound Transit Board on July 28, 2011, and amended on April 25, 2013. In April 2015, the Sound Transit Board established the baseline budget and schedule for the project.

Sound Transit staff worked closely with emergency responders in Bellevue, Mercer Island and Redmond to develop a comprehensive emergency preparedness training plan for the East Link and Downtown

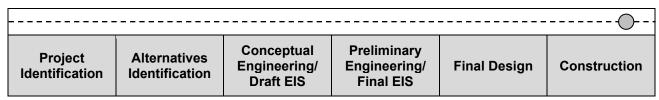
Redmond Link Extension projects. This agreement covers the training costs and equipment identified in the jointly agreed emergency preparedness training plan.

Emergency responder training is a prerequisite for revenue service. Training includes responder familiarization of Sound Transit system, guideways, and stations. Emergency responders along with Sound Transit staff will conduct simulated emergency scenarios during pre-revenue service in preparation for opening the extensions to the public. Discussions with the cities identified the need for new specialized equipment, in addition to the previously Sound Transit purchased equipment, for the emergency responders to be able to provide effective emergency responses.

In order to support the start of System Integrated Testing, Sound Transit purchased special lifting tools, and loaned this equipment to the fire departments, so they be able to lift LRV's in an emergency response situation. This agreement will transfer ownership of this equipment to the Fire Departments.

The agreement and payment represent Sound Transit's full and final cost sharing to the cities for emergency responder training and equipment costs. Sound Transit's future obligation is limited to participation and access for the emergency responders to conduct ongoing needed training. Emergency responder training for East Link is expected to start in Spring of 2023.

Fiscal information

The fiscal summary of this action is funded through the East Link and Downtown Redmond Link Extensions. The total cost of the First Responder Training and Equipment is provided in the table below.

This action is within the baseline budget and sufficient monies remain after approval of this action to fund the remaining work in the construction services phase. This action does not impact the affordability of any other system expansion project.

Within the East Link Extension baseline budget, \$33,718,000 has been allocated to the System Testing and Start Up phase. The proposed action will commit funding of \$1,139,343 to fund equipment and first responder training and leave a remaining budget of \$22,207,071.
