Proposed action

Approves Sound Transit's annual 2024 Public Transportation Agency Safety Plan submittal to the Washington State Department of Transportation's State Safety Oversight Office.

Key features summary

- This action allows Sound Transit to satisfy Federal Transit Administration requirements in 49 CFR 673 to maintain a compliant Public Transportation Agency Safety Plan and provide this plan to the State Safety Oversight Office in the Washington State Department of Transportation.
- This plan must be approved on an annual basis, or as needed, when continual improvement activities deem an update is needed.
- The 2024 revision includes updates related to regulatory updates, audit findings, organizational changes, updated safety performance measures and targets, and other internal plan revisions. Per state and federal requirements, the Board of Directors must approve the revised Agency Safety Plan prior to CEO signature and submittal to WSDOT.

Background

The FTA passed the 49 CFR 673 Public Transportation Agency Safety Plan rule on July 19, 2018. The rule requires all rail transit agencies and bus agencies that receive 5301 funds to develop a Public Transportation Agency Safety Plan using a Safety Management System framework. Sound Transit prepared an Agency Safety Plan in compliance with the aforementioned rule, approved by the Board in June 2020. This plan must be reviewed on an annual basis or revised as needed for continuous improvement.

Sound Transit's Agency Safety Plan was developed through work with the FTA, internal and external operational partners, and research and inventory of internal processes. The Safety Department worked with operating partners, Washington State Department of Transportation's State Safety Oversight office, and internal stakeholders to accurately document Sound Transit's approach to safety management. The Safety Department researched and inventoried related safety documentation to aide in shaping the plan and provide a solid foundation for future implementation activities.

The Agency Safety Plan is organized by federal plan requirements using the Safety management System framework: Safety Management Policy, Safety Risk Management, Safety Assurance, and Safety Promotion. These four components work in a cycle, allowing for continuous improvement of Sound Transit's processes and methodologies in a changing environment.

- Safety Management Policy reiterates the Agency Safety Policy and sets the tone for safety
 management at the agency. It includes specific references required by the regulation.
 Additionally, this section describes the employee reporting process, integration and coordination
 with public safety and emergency management, and high-level roles and responsibilities as they
 relate to safety activities.
- Safety Risk Management describes the process for managing safety risk at the agency.
 Specifically, it defines the hazard identification, analysis, evaluation, and mitigation processes utilized by agency personnel.
- Safety Assurance provides the means to measure and assess safety performance through audits, investigations, system reviews, management of change and continual improvement activities.
- Safety Promotion focuses on communicating safety information and training staff to use these
 processes. This is how the Safety Management System effectively evolves to meet the everchanging environment and provide feedback to employees on identified hazards.

The Agency Safety Plan will undergo annual review and must be approved on an annual basis or when needed should continual improvement activities require an update.
