



- Baselined Stride with full ZEB service
- Participated in WA State Clean Fuels Standard –agency netted \$575,000+ for Q1 & Q2 of 2023

#### **Building Resilience**



Integrated climate resiliency considerations into agency design requirements

#### **Maximizing efficiency**

- Initiated 8 Efficiency and Sustainability Program (ESP) projects to enhance resource conservation and pilot new sustainability approaches.
