- B. **Motion No. M2025-65:** Authorizing the chief executive officer to execute an agreement with the City of Portland to purchase their three Brookville LRVs and sell Tacoma Light Rail's three Skoda LRVs for a total amount of \$16,596,000, with a contingency of 10 percent, for a total authorized contract amount not to exceed \$18,255,600, plus applicable taxes, contingent upon Board adoption of Resolution No. R2025-30.
