#### **Work of Other Auditors**

A financial statement audit was performed by Crowe LLP of Sound Transit. Professional audit standards require us to evaluate relevant work done by other auditors and communicate certain matters to the governing body.

- We performed procedures to ensure we could rely on the work of the external auditors and reference their audit in our audit report. These procedures included consideration of attendance at key meetings, evaluation of the firm's last peer review report, review of the other auditor's work, review of the other auditor's results and communications with the other auditor.
- We did not become aware of any instance in which the work of the other auditors gave rise to concern about the quality of their work.
- There were no limitations that restricted our analysis of the other audits.
- We did not become aware of any instance in which a material misstatement of the financial statements has or may have resulted from fraud or suspected fraud.

#### **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Authority operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Sound Transit from January 1, 2024 through December 31, 2024.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Authority's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2024, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Procurement public works and professional services
- Compliance with public works projects change orders
- Accounts payable credit cards, electronic fund transfers
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

#### INFORMATION ABOUT THE AUTHORITY

In 1992, the Washington State Legislature authorized King, Pierce, and Snohomish counties to create a regional transit authority to plan, build and operate a high-capacity transit system within the Puget Sound region's most heavily traveled corridors. The Central Puget Sound Regional Transit Authority, doing business as Sound Transit, was established September 17, 1993. The Authority comprises five subareas within the contiguous urbanized areas of Snohomish, King, and Pierce counties. The service area is home to over 3.3 million people, or 80 percent of the three-county population.

Sound Transit is governed by an 18-member Board made up of local elected officials proportional to the population included in the Sound Transit district. Three members are from Snohomish County, 10 from King County, and four from Pierce County. The last seat is held by the Washington State Secretary of Transportation.

To date, Sound Transit has three phases of its System Plan: Sound Move, Sound Transit 2 (ST2), and Sound Transit 3 (ST3). "Sound Move" was a 10-year plan approved by voters in 1996 to implement commuter rail (Sounder), regional express bus service (ST Express) and light rail (Link) operations. Sound Move was completed in 2016. "ST2" is a 15-year plan approved by voters in 2008 to provide further expansion of facilities and service to the region with anticipated completion by 2023. "ST3" is a 25-year plan approved by voters in 2016 to expand light rail, connecting 16 cities and adding 62 new miles, and adding Bus Rapid Transit and extending Sounder train platforms.

Sound Transit has implemented, and is operating, the following services: Sounder Commuter Rail running daily from Everett to Lakewood; 29 ST Express Bus Routes; Link Light Rail running 22 hours a day now operating on 30.5 miles between Lynnwood and Angle Lake. The extension of service from Northgate north to Lynnwood added four new stations—Shoreline South/148th, Shoreline North/185th, Mountlake Terrace, and Lynnwood City Center—and opened to the public on August 30, 2024. The extension of the 2 Line (East Link) began service on April 27, 2024, operating between South Bellevue and Redmond Technology stations, adding 6.6 miles and eight new stations to the system. Tacoma Link runs through downtown Tacoma, Hilltop Extension opened to the public on September 16, 2023. The length of the alignment is 2.47 directional miles, running from Old City Hall Station to St. Joseph Station.

In 2024, the Authority had almost 41.9 million boardings on its trains and buses, an 11 percent increase from 2023. The Authority had 1,430 regular full-time employees and 10 full-time temporary employees at the end of 2024.

The Authority receives revenue through taxes (sales tax, motor vehicle excise tax, property tax, and rental car tax), passenger fares, other local contributions, federal and state grants.
