Proposed action

Authorizes the chief executive officer to execute a Law Enforcement Services Agreement with the City of Lynnwood for a one-year term in an amount not to exceed \$355,409.

Key features summary

- This action would authorize a one-year enhanced Law Enforcement Services agreement to be executed with the City of Lynnwood for an amount not to exceed \$355,409. The agreement includes two annual options to extend, subject to Board approval.
- With the expansion of Link light rail into Snohomish County, Lynnwood City Center station
 experiences similar challenges to existing terminus stations, requiring enhanced Law Enforcement
 Services.
- Under the agreement, Lynnwood Police will handle emergency and non-emergency calls on Sound Transit property, conduct patrols, engage with customers, maintain a presence on platforms and trains, and investigate felony, misdemeanor, and infraction incidents as needed.
- This agreement allows the City to be reimbursed by Sound Transit for Police costs not to exceed \$355,409 per year. This temporary arrangement will provide time for Sound Transit to establish a law enforcement strategy in all counties in its service area.
- The City of Lynnwood, in coordination with Sound Transit, calculated the \$355,409 cost based on 40 hours per week at their fully burdened rate of \$170.87 per hour. The amount requested will cover the initial one-year term. Staff will return to request additional funds to fund the one-year options to extend, if necessary.
- The Lynnwood City Council authorized this Police Services Agreement on May 12, 2025.

Background

Since 2008, Sound Transit has contracted with the King County Sheriff's Office (KCSO) to provide enhanced police services that supplement local law enforcement for Link and Sounder operations. Local law enforcement agencies along our system maintain jurisdiction over incidents and events occurring along the network.

Under Sound Transit's contract with the King County Sheriff's Office (KCSO), the Sheriff's Office responds to situations where local law enforcement chooses not to exercise jurisdiction. For instance, while jurisdictions may monitor system related events and incidents, they may choose not to assert jurisdiction due to resource limitations or other competing priorities. The current Agency Agreement with KCSO (GA 0078-18), signed in March 2019, extends through 2026 with mutual options for two additional seven-year extensions. In 2019, the estimated expenditure under the agreement was \$17.8 million; in 2024, it was planned at \$26.3 million but is expected to decrease in 2025 to approximately \$19 million due to staffing constraints. Law enforcement for transit bus services is not included in Sound Transit's contract with KCSO. Policing for Tacoma Link is handled by off duty officers from the Tacoma Police Department through individual contracts.

With the completion of the Lynnwood Link Extension, Sound Transit now provides rail service into Snohomish County, requiring adjustments to Sound Transit's law enforcement coverage. There is now a need to enhance law enforcement services in Snohomish County to ensure safety and operational continuity. KCSO will continue providing coverage for recent and upcoming service extensions within King County.

Sound Transit is seeking a temporary agreement with the City of Lynnwood for supplemental law enforcement services in Lynnwood while exploring long-term solutions to provide enhanced law enforcement coverage in its entire service area.

As part of this broader effort, Sound Transit is actively working to establish a comprehensive law enforcement strategy across its service area in Pierce, King and Snohomish Counties. This approach will ensure consistency, coordination, and effectiveness in responding to safety and security concerns throughout the transit network.

Fiscal information

This action for \$355,409 will be funded from Safety department's annual operating budget. Within the Services category, the security service budget is \$57,959,248, of which \$355,409 is estimated to be spent from this action in the remainder of 2025 and is currently within the agency's budget authority. After this action's approval, sufficient budget remains to cover remaining annual expenditures; funding for the additional years of the contract will be included in future annual budget requests.

This action does not impact the affordability of the agency's Financial Plan, as the services are already incorporated in the annual operating plan.
