Dog Amenities Near Stations



Marymoor Dog Park

Amenities near Marymoor Village Station

- Passengers will be able to access Marymoor Park, a regional 640acre park via trail.
- The park is dubbed "Doggy Disneyland" for its well-known 40acre off-leash dog area.





Peer Agency Pet Policies

Sound Transit's rules for pets

- Pet may ride if carried in small container.
- Service animals allowed without container under full control of their handlers. Not on seat.

Administering the policy

- Generally, if pet is under control of handler and not posing a safety concern, Sound Transit personnel do not engage.
- It is not customary for Sound Transit personnel to ask for details on service animals.

National Peer Agency Pet Policies

Peer light rail operators:

 Trimet – Portland, Dallas Area Rapid Transit (DART), Valley Metro - Phoenix, Regional Transportation District – Denver (RTD), and LA Metro allow pets in closed containers.

Alternative approach:

Massachusetts Bay Transportation Authority (MBTA) allows
 pets in containers and large pet dogs that don't fit in a
 container if leashed. Restrictions around peak hours and
 large events.



Passenger Experience Considerations

Passenger Experience

Policy opportunities:

- Inclusion while respecting current passenger experience
- Focus on pet behavior and handler control

Policy considerations:

- Impact to passenger comfort & safety perception
- Hazard analysis (i.e., egress, cleanliness)
- Pet safety

Proposed Motion No. M2025-XX principles for consideration:

- Dogs allowed on leashes or in carriers when under control of the dog handler;
- Sound Transit may limit dogs based on the animal's behavior, or under certain riding conditions such as crowded events;
- Sound Transit will consider whether to designate certain train cars as dog-friendly;
- No fare will be required for dogs on Sound Transit buses and trains; and
- No changes to rules allowing service animals, or the existing rule allowing pets if they are carried in small containers.
