

## Motion No. M2026-05

A motion of the Board of the Central Puget Sound Regional Transit Authority updating committee chairs, vice chairs and members.

### Background

On February 27, 2025, the Board approved Motion No. M2025-11 appointing committee chairs and members for two-year terms. These appointments were updated by the Board on May 22, 2025 through Motion No. M2025-26 after Dow Constantine left the Board and became Sound Transit's chief executive officer.

Board members Shannon Braddock and D'Sean Quinn left the Board on November 25, 2025, and Board members Nancy Backus, Christine Frizzell and Bruce Harrell left the Board at the end of December 2025. On December 9, 2025, the King County Council confirmed King County Councilmembers Steffanie Fain and Teresa Mosqueda as Sound Transit Board members effective immediately, and Seattle Mayor Katie Wilson and Tukwila Mayor Thomas McLeod as Sound Transit Board members effective January 1, 2026.

The Snohomish County Council has not yet confirmed a Board member to fill the vacancy left on the Board for Snohomish County.

This action will update committee chairs and members for 2026 to coincide with the current Board Chair and Vice Chair terms.


