PROPOSED ACTION

Authorizes the chief executive officer to execute (1) an agreement with the City of Milton to provide expedited permitting, design, design review, and construction services for the Tacoma Dome Link Extension and (2) Task Order 1 in the amount of \$19,560, with a 10% contingency of \$1,956, for a total authorized agreement amount not to exceed \$21,516.

KEY FEATURES SUMMARY

- This action follows from the Partnering Agreement between the City of Milton and Sound Transit executed on April 18, 2018.
- The Project Administration Agreement defines a relationship for the City to expedite permitting, design, design review, and construction services for Tacoma Dome Link Extension (TDLE).
- Task Order 1 covers the Alternatives Development phase and is anticipated to go through June 2019. This Task Order will reimburse the City for staff time to participate in individual meetings between the City and Sound Transit staff and to review and comment on documents produced by Sound Transit.
- The expectation is that a Task Order 2 will be executed towards the end of the Alternatives Development phase and prior to or at the end of Task Order 1, which will cover reimbursement to the City staff and/or consultants for participation in the environmental review, conceptual engineering, or other work in the next phase(s) of the TDLE project.
- Task Order 1 is a total of \$19,560 with a 10% contingency of \$1,956. The Task Order includes 56 hours for participation in individual meetings and 240 hours for review and prep.


BACKGROUND

The Tacoma Dome Link Extension project connects to the Federal Way Link Extension at the Federal Way Transit Center and will travel south and then west to the Tacoma Dome. The total extension for this project will be approximately ten miles. There are four stations and two parking facilities included in the ST3 Plan assumptions for the project: South Federal Way station with parking, Fife station with parking, East Tacoma station, and Tacoma Dome station. The project will travel through the Cities of Federal Way, Fife, Milton, and Tacoma, and will also travel through the reservation of the Puyallup Tribe of Indians. This project also includes the Operations & Maintenance Facility: South, which will be sited somewhere between the Cities of Kent and Tacoma.

This action will reimburse City of Milton staff time for participation in document reviews and individual meetings throughout the Alternatives Development phase.

Future related actions will include future Task Orders under this Project Administration Agreement; the next (Task Order 2) will likely be executed in spring/summer 2019 to set up staff reimbursement funding for participation in the environmental review, conceptual engineering, and/or other work.

FISCAL INFORMATION

This action is within the authorized project allocation to date and sufficient monies remain after approval of this action to fund the remaining work in the third parties phase as contained in the current cost estimate.

The authorized project allocation to date for the Tacoma Dome Link Extension project is \$125,673,000. Within the third parties phase, \$50,000 has been allocated for the City of Milton agreement. This proposed action will commit \$21,516, which includes a 10% contingency, leaving a remaining budget balance of \$28,484.
